PROGRAM

JAMIE SMITH introduced Liz Godbehere and Chrissy Schmidt from LifeCenter Northwest. Liz is a former nurse at Kootenai Health, a Kootenai Health Board Member and also works for the Center. Crissy is in hospital development with LifeCenter Norwest. They discussed organ and tissue donation in our region, covering Alaska, Washington, Montana, and North Idaho.

LifeCenter Northwest is a non-profit, federally designated organization that works with hospitals, medical staff and families of organ and tissue donors to provide remarkable gifts to save lives when tragedy strikes. The goal of LifeCenter Northwest is to ensure all hospitals have strong organ and tissue programs. Their work is made possible through the great relationships with partner hospitals.

Organ donation is extremely rare, as less than 1% of people die in a way that allows them to be a donor. Organ donation requires the death take place in a hospital, with a person hooked to a ventilator/life support. One organ donor can save up to eight lives with donation of major organs including heart, lungs, kidneys, liver. Tissue donors are the "unsung heroes" with donations of skin for burn victims, heart valves, cartilage, ligaments, tendons, bone, etc. One tissue donor can enhance up to 150 lives. The average case time recently is 54 hours. Organ and tissue donors stay in the hospital up to five days after the time of death to harvest organs and tissues. This gives the medical staff and family time to do what is needed, as labs are run to determine viability of organs. Families are provided 18 months of bereavement support through the program.

Choosing to be an organ donor on your drivers license or ID provides your legal authorization to donate for live-saving or healing transplants. This is legally binding for donors over 18, if you are entered into the donor registry, regardless if your family has opposition to donation.
