#### **PROGRAM**

WAYNE C., Attorney. "My Experience Before the U.S. Supreme Court.

Wayne, a resident of Rossmoor gave us a "through attorney's eye" view of his appearance before the U.S. Supreme Court in 1983. His case, Vincent v. Los Angeles, was a First Amendment case re: freedom of speech. As attorney for a candidate for Los Angeles City Council and COGS, which made signs for his campaign, he argued that the First Amendment prevented the City from removing temporary cardboard signs posted on behalf of the candidate on public property.

Wayne talked about the Court's history, customs, and procedures. He showed photos of the Court's stately chamber, the justices, and the type of signs at issue in the case. He told us of how lawyers are expected to begin their address to the Court with "Mister Chief Justice and may it please the Court." He showed us two writing quills that he was given in keeping with a tradition that went back to 1800's. He explained that opposing attorneys are each given 30 minutes to present their cases. He talked about his interactions with Judges John Paul Stevens and Thurgood Marshall. He thought he had persuaded Stevens to his client's side of the case, and feared that he had lost Marshall's vote by an answer to one of his questions that the other justices found humorous, at Marshall's expense. In the end, the Court found in favor of Los Angeles in a 6-3 decision. Stevens wrote for the majority; Marshall joined in the dissent. Wayne concluded by saying that his client's sign business prospered because the competition complied with the L.A. ban on signs, while his wayward client ignored it.
