A Million Thanks is a nonprofit organization that provides support and appreciation to our active and veteran military men and women through sending letters. This year we are partnering with them to write letters to be delivered to our brave men and women in the U.S. Armed Forces to arrive AFTER THE HOLIDAYS.

We will be treated to live holiday music by the Rotary Badcats Band (Ann Louise Christensen on piano, Joe Tortomasi on bass, Don Andrues on guitar, and Geno Escarrega on percussion), while we enjoy visiting with our fellow Rotarians

and writing our letters.

Shauna Fleming founded A Million Thanks in 2004, when she was just 15 years old. The campaign began as a community service project in Orange County, California, with the goal of sending one million cards and letters of appreciation. Within six months of starting, Shauna and her team of volunteers reached the initial goal of one million letters. To date, A Million Thanks has distributed more than seven million letters to U.S. troops stationed around the world



Our guest speaker today, The Pasadena Showcase House for the Arts's President Matt McIntyre, pointed out that the Pasadena Showcase House is the most successful in the country with over 25,000 viewing guests and donated over \$1 million to local San Gabriel music programs just this past year. He promised to go over the history, the design process, and some gossip.

President Stephen Smith opened our meeting promptly at 12:30 pm and introduced **PP Phil Miles** on guitar and **Ann Louise Christensen** on piano. PP Phil decided that he had enough of Christmas carols and that since the Showcase House raises money for music programs, then it must be a friend of music, so let's sing You've Got a Friend by Carole King.

Russ Guiney read quotes about Giving and Service (penned by **Gary Kearney**, stuck at home with maintenance issues), notably "The meaning of life is to find your gift... the purpose of life is to give it away" - Shakespeare.









We then were treated to our old friend Ross Jutsum, of Florida now, but coming back to visit friends in Pasadena, as he sat down at the piano and led us on a holiday favorite and then a song he wrote for the 1987 Tournament of Roses President and Rotarian PP Fred Soldwedel, Sr., about a world of roses and beauty all around us entitled "A World of Wonderrs". PP Mel Cohen asked him if he considered coming back as a member for weekly visits, instead of just an annual visit.

PP Mary Lou Byrne began her introduction of our speaker, Matt McIntyre, by saying that she was contacted by Garrett, looking for a judge to marry him and Matt, and she welcomed the chance to perform the ceremony herself – they have been friends ever since. Mary Lou mentioned that Matt is a third-generation Pasadenan whose parents met at Canterbury Records.

Matt started out by giving us the history of the Pasadena Showcase House for the Arts, which really started as a project by the Pasadena Junior Philharmonic to raise funds to bring the LA Phil to Pasadena in 1948 with casino nights and "television watching parties." They became an independent nonprofit entity in 1997, and now specifically to youth music programs in the San Gabriel Valley. The focus of the House is to raise funds for the local music programs, and since 1985 they have also held Instrumental Competitions for emerging young pre-professional talent, judged by LA Phil professionals – they have distributed over \$700,000 in



prize money over the years. In total, over \$1 million was given to local charities in 2024 alone.



The idea for the Showcase House of Design (which is the benefit put on annually by the organization, the Showcase House for the Arts) began in 1965, with the first House in the Four Oaks section of San Marino – and this year's House features The Bower Estate and Gardens, a 1928 Reginald Johnson estate design with extensive gardens that extend down a grand hillside to the pool below. The House is over 10,000 square feet, and will feature 30 rooms with individual designers, and five landscape architects.

Past Houses in the area include The Wayne Manor (of Batman fame) and the house that burned down (that people thought was the Wayne Manor, although it had been a Showcase House twice). The house that was The Beverly Hillbillies house of TV fame was the House one year, but then that house burned down and was rebuilt to a grand home still under construction.

Matt then went into the "behind the scenes" of how Houses are chosen (there is a secret book of all the qualifying homes, with two staircases, over ten thousand square feet in size, and an empty flat acre for the Showcase shops – only 2% of all homes in the Greater Pasadena area qualify), how designers are chosen, and how the House committee of 240 volunteers work for months tying the whole design and events together into one seamless experience that hosts over 25,000 guests annually. He gave one example of the designer competition for the rooms, where over seven designers vied for the dining room this year, including Karen Billman, but that once all gave their presentation, the committee chose the designer that best represented what they were looking for as an overall "look." This went on over and over for each of the rooms, and the best designs won. Karen agreed that this was the process (as she won the maid's quarters downstairs) and it represented a lot of work to find the style and materials that everyone could agree on. "Nothing comes overnight'" said Matt.

A special editorial note: Our own Rotarian Judy Taylor has done over 17 Showcase Houses as a designer.

We had questions: What happens to the owners? Who pays for it? How do you choose the vendors in the Village? Does being the Showcase House raise its market value? How do you get the house designs to be consistent? Do you practice sustainability in the choice of materials and the use of up-cycled products?

Basically, the House is rented from January to June, and the owners move out. The homeowners have to contribute funds for the labor in certain rooms, like the kitchen and master bedroom, but the designers provide the rest through vendor donations and marketing budgets. The Vendors in the Village go through the same vetting process as the designers, with variety and quality as the main points.

On sustainability, the world is asking for non-toxic products and up-cycled and recycled ideas, and the designers know that creating a smaller environmental footprint is what many clients want these days. Even the garden designers are building water-wise features and benefits into the landscaping design.

Everyone agreed this was an excellent program and we look forward to visiting the Pasadena Showcase House of Design next April 2025.


