The Scoot Zone

It was an emotional day as we came together after four weeks apart. There were lots of hugs and more than a few tears as we reconnected over lunch. After ringing the bell at 12:30, **President Stephen Smith** asked us to remain seated while he gave a short but beautiful statement expressing heartfelt sympathy to all those affected by the Eaton Fire and urging us all to come together and join in the recovery ahead.

Past President Mary Lou Byrne, accompanied by Ann Louise Christensen on the piano and the Four Way Test Singers (Don Andrues, Allison Burgos, Phyllis Currie, Hillary Schenk, James Doyle, Gary Kearney, and Eric Olson) led us in singing You've Got a Friend in Me, dedicated to everyone who had been displaced or suffered losses in the fire.

Hans Rosenberger gave the Inspiration, a poem by Maya Angelou called When Great Trees Fall: https://poems.com/poem/when-great-trees-fall/ There were more than a few tears and a rousing round of applause at the end.





On a lighter note, we welcomed two new members today, both sponsored by Past President Howard Raff. Nick Duretta (pictured right of President Stephen) retired from a 45-year career in communications management and is now enjoying his second career as a writer of mystery novels. (This reporter read his first one, A Deadly Walk in Devon, and it's great! The second one is coming out next week.) Nick lives in Pasadena with his husband and is excited to get to know his fellow Rotarians. Adam Kawasawa (pictured left) (co-sponsored by Curtis Smith) is a third generation Angeleno and second-generation real estate broker with 18 years' experience. He is married to wife Tinna Yu and owns a brokerage in Pasadena called Flow Properties. Adam says he looks forward to being of service to the community as a member of the IMPACT Club.





Sergeant at Arms Robert Lyons helped with the guest introductions. Rotarians hosting guests this week were **Scott Carlson**, **Bob Risley**, **Mary Lou Byrne**, **Angie Pizano**, and **Pat Wright**. We also welcomed visiting Altadena Rotarian Mark Mariscal, who was in amazingly good spirits despite having just lost his home in last week's fire.

Announcements:

Helen Baatz, co-chair of Community Grants, announced that her committee has pivoted in light of recent events, and this year's area of focus is changing from veterans' services to fire relief. This announcement was greeted with a big round of applause.

George Ricciardella of Impact Drug & Alcohol Treatment Center shared that his facility has been evacuated and one of its sober living facilities has burned. However, he "celebrates their grace and resilience." And because of donations of gift cards from Pasadena Rotary, all 28 displaced people from the burned-out facility "have what they need." He recalled that early in his career as a fundraising professional he received a letter addressed to "Dear Kind Folk," and thanked the "kind folk" of Pasadena Rotary for their support.

Vivian Kambe of the Pasadena Community Foundation (PCF) announced that PCF established a Fire Relief Recovery Fund last week with \$100,000 seed money, and it's already grown to \$3.7 million. She expressed her thanks to everyone who has donated, urged others to consider donating, and commended PCF President **Jennifer DeVoll** for her tireless work in this time of crisis. Dean Billman announced that his cousin in far-off Ohio is working with his Rotary District 6690 to send aid to the victims of the California fires. They are directing donations to the Wildfire Disaster Relief Funds for our own District 5300 *https://www.district5300.org/ca-wild-fires/* and also District 5280 (Los Angeles) *https://rotary5280.org/page/2025-wildfire-disaster-relief/* It's good to know our far-off Rotary friends have our backs!

And speaking of Rotary friends having our backs, **Past President Ken Hill** took the mic to acknowledge and thank former Pasadena Rotarian Mary Farley Bowser, who actually moved out of her house in Sierra Madre so that **Ken** and his wife Freddi could move in while they are evacuated from their (thankfully still standing) house in Altadena.

President Stephen also announced that our Rotary Board secretary unfortunately lost her home in the fire and has had to resign from the secretary position. We are looking for someone to fill the rest of the term (through June 30 of this year). Board meetings are at 5:00 p.m. on the third Thursday of the month and generally last for about an hour. Please contact President Stephen at president@pasadenarotary.com if you are interested in serving.

And in non-fire-related news, the 35th Annual Garbis Der-Yeghian Peace Conference will take place on Saturday, January 25 at the Richard Nixon Presidential Library. Details above.

After the announcements, we had a brief open mic session to discuss disaster-related issues. **Past President Mel Cohen**, a longtime insurance professional, gave some good tips:

• There is a ban on any insurer from canceling your homeowner's policy and any notice you have received is void. Details here: https://abc7.com/post/california-issues-temporary-ban-home-insurance-cancellations-palisades-eaton-fire-areas/15788773/

- If you have been affected by the fire, Mel is available to review your insurance policy with you.
- After you are able to move back into your home in the fire area, or get access to your burned home, don't sign anything without getting advice from Mel or someone else who knows about disasters! And if you do sign a contract to rebuild, the maximum deposit is 1% of the price of \$10,000.
- Price gouging is illegal: Hotels and other essential services can only raise their prices by 10% in emergency situations.
- PCC has set up a Disaster Recovery Center at 3035 E. Foothill Blvd, the PCC Community Education Center. It will be open all week from 9 a.m. to 8 p.m. https://pasadena.edu/fireupdates/
- Finally, Mel said, "I'm here to help, not to hustle."

Lisa Cavelier of the Pasadena Boys and Girls Club announced that the Boys and Girls Club never closed during the disaster. 49 client families, 2 staff members, and one board member have lost their homes, but they are staying open while the schools are closed. They are soliciting funds that will go directly to the families in need. The biggest need is not material goods like clothing, but gift cards to places like Target.

Mark Mariscal of Altadena Rotary commended the Pasadena Community Foundation which, he said, is "leading the charge" for relief in Altadena.

Scott Carlson introduced our speaker, prominent novelist Naomi Hirahara. (This reporter has read her books and they're great!). Naomi grew up in Altadena and has been friends with Scott's wife, Yvonne, since they were in junior high school. Naomi began by showing us a photo of her multi-racial, multi-ethnic third grade class at Loma Alta Elementary School in Altadena, and saying sadly, "I just found out my childhood home is gone. It's not the same as losing a current home, but it's a loss." She now lives in Pasadena but quoted Mayor Victor Gordo, who says of Altadena, Pasadena, and South Pasadena, "we're all Denas!"

The title of Naomi's talk was A Pasadena Girl Investigates, and she focused on Japanese culture in Pasadena. Despite the fact that Japanese/Japanese American citizens were interned during WWII, "Pasadena has embraced Japanese art and culture from the early 1900s."





One fascinating example: The Issei/Nisei float in the 1941 Rose Parade. The Japanese American community had a float with five princesses who were chosen from 1,000 applicants at a gala event in Pasadena. The Issei (first generation Japanese) wanted the princesses to wear kimonos. The Nisei (their children, the second generation) wanted them to wear Western evening gowns, which they thought would better harmonize with the float's depiction of Washington DC and its cherry blossoms (and a sign on the back saying "God Bless America"). The result? Two princesses in kimonos and three in evening gowns. And the float won the Theme Prize that year! Ironically, this was January 1, 1941, just under a year before the attack on Pearl Harbor and the detention of the Japanese in Pasadena.

Naomi then told us about Kenneth Masao Nishimoto. He was born in Tokyo in 1907 but came to the US to study architecture at USC. He led tours to Japan for his fellow architects, which

influenced many of them including Whitney Smith, who designed the Tea House at Descanso Gardens.

Nishimoto was interned at the Gila River War Relocation Center in Arizona, but even from there he was able to collaborate with a USC classmate to organize the barracks. He even entered and

won third prize in a contest to design "the modern American home." After the war he and his classmate designed homes in Pasadena and even worked on the Pasadena Public Library.

Finally, Naomi shared that her mother was from Hiroshima and was present when the atom bomb fell. Today, said Naomi, Hiroshima represents peace. Who knows, she asked, what Altadena will represent in the future? Something will be re-built. "This is a time for mourning, but I have a glimmer of hope that it doesn't mean Altadena is gone [for good]."

After a short Q and A, Naomi raffled off copies of her books (lucky winners were **Scott Vandrick** and **Phyllis Mueller**), and we all left the meeting feeling grateful to have been together in these trying times.


