MIGUEL MARQUEZ

"Future Visions of Pasadena"

Introducer: Paul Martin



Before joining the City of Pasadena in 2022, Miguel Márquez served as the Chief Operating Officer of the County of Santa Clara, responsible for all operations of the county, the largest in Northern California.

Prior to his role in Santa Clara, Márquez served as an Associate Justice of the California Sixth District Court of Appeal, as the County Counsel for the County of Santa Clara, as the General Counsel of the San Francisco Unified School District, and as a Deputy City Attorney in the San Francisco City Attorney's Office. He began his public service career as a Deputy

County Counsel in San Mateo County. Márquez has also worked for two private law firms (Cooley Godward LLP and Remcho, Johansen & Purcell), and as a management consultant at KPMG Peat Marwick, where he was part of a national financial and organizational consulting practice.

Márquez's parents immigrated to the United States from México with only a limited amount of formal education. Spanish was his first language, so programs like Head Start were critical to his early education. These formative experiences inspired Márquez's commitment to public service.

A native of Sacramento, Márquez received his law degree from UC Berkeley Law School, his master's degree in public policy from the John F. Kennedy School of Government at Harvard University, and his bachelor's degree in public policy from Stanford University.

I'm sure P-E Hillary did a fine job this past Wednesday and am looking to be back next week. Want to post some statistical information about Altadena regarding the Eaton fire, from LA County fire. (Note that Altadena had over 17,600 structures).

Destroyed - 9,366 total 6,000 single family 97 multi-family 5 mixed (residential/commercial) 153 commercial 3,111 other minor structures **Damaged** - 1,062 total 742 single family 28- multi-family 28- multi-family 2 mixed (residential/commercial) 32 commercial 258 other minor structures

I have read where the Southern California fires will be the most expensive natural disaster in the history of the United States. The suddenness and severity of this disaster is simply staggering and unimaginable. There are a number of projects that Pasadena Rotarians are working on

which I will report on soon.

District 5300 has created a fund to assist those impacted by the California wildfires. These funds will be distributed in phases. In Phase I the District has allocated \$40,000 to grant funds to distribute to clubs who develop a project assisting people impacted by the devastation of the fires. A zoom meeting will also be held on 01/29. Stay tuned.



After the devasting urban wildfires in Altadena and Pacific Palisades, California, our guest speaker today was a trauma specialist and a "Clinical Incident Debriefer – traveling to sites to quickly help mitigate future mental health issues for survivors."

President-Elect Hillary Schenk rang the big brass Rotary Bell to start our meeting promptly at 12:30pm, and she introduced our song leader **Jonathan Edewards** who led us in a hopeful medley of two songs, Jackie DeShannon's "What the World Needs Now is Love" with the inspirational message "Let There be Peace on Earth" by Jackson-Miller and Sy Miller.

Tyros' member Ms. **Morgan Nadeau**, honoring the late Dr. Martin Luther King, quoted "We just learn to live together as brothers, or we will die together as fools." We applauded her choice of inspiration in these trying times.

PE Hillary introduced our guests today:

• **Sandy Goodenough** introduced her husband, retired LA Arboretum CEO Richard Schulhof; Sandy pointed out "This is the guy you want to be with in a disaster!" (Sandy and Richard lost their home in the Altadena fires).

Howard Raff introduced Bridget Lawlor, of Pasadena Heritage, who is looking at our Corporate Membership program.

Mary Lou Byrne welcomed former Rotarian and City Business Developer Eric Duysart, now a consultant.

• **PP Mike Farrand** celebrated his wife, Terrie Farrand today.

Announcements:

 $\cdot\,$ DG Nominee Dennis spoke about our District's and Los Angeles District 5280's efforts to organize response to the immense needs within our communities affected by the wildfires. The

Districts have created websites to match people with needs and resources, and they are figuring out the rules for grants right now. He spoke of his visits these past two weeks to local clubs, and mentioned how San Marino club invited the devasted Altadena club to visit, and 17 members were received with open arms, with pledges of support. He also mentioned that nationally, Rotary is coordinating with other clubs that have helped in Hurricane recovery on the East Coast, and other recent disasters. He mentioned that visiting local relief centers don't need any more clothes (there is not a real need compared to the donations), and they have accumulated \$21,000 in gift cards, but not sure yet what people need. He did say that efforts are on track for the Peace Conference this Saturday.

Vivian Kambe of Pasadena Community Foundation reported that they were a focal point for financial donations to help the many non-profits who also jumped right in to help – PCF seeded the fund with an initial \$100,000 of their money, and now donations stand at over \$7 million. They have contributed to many local charities who are helping: Pasadena Boys and Girls Club, Door of Hope, Fletcher Center, and Emmon, who collected food and water for over 1,000 people.

PE Hillary announced that the focus of our Community Grants this year will be on Disaster Relief instead of our planned focus on veterans, which seems appropriate right now.

• **PE Hillary** also mentioned that our club sprang into action, even as the fires were first reported – members arrived at PCC for the relief center. With a current evolving inventory of needs and emergency services who are addressing the immediate crisis, she said our role will probably be as "The Second Wave", helping the very long process of rebuilding.

Cathy Simms gave us a history and update on our "Caring Little Hearts" Project:

In 2016 Club President Shel Capeloto did our first Global Grant project, and after forming a committee (which included Cathy), they took advice from the San Marino Club who had done a Global Grant and referred a Club from India to possibly work with. Pasadena Rotary with our sister club Madras South Rotary in Chennai India, formed to provide heart surgeries for children

with congenital heart disease. Each of the surgeries were for children of very poor families.

Through our first two Global Grants, we completed 401 surgeries. Now through our 3rd Global Grant, 63 more surgeries will be completed. President Shel as well as Cathy and her husband had the opportunity of going to Chennal, meeting with Rtn. Sara, the Madras South Rotarians, administrators of the hospital, surgical staff, family members and some of the children. Cathy says it was a life changing experience. Thank you to Pasadena Rotarians who supported the

surgeries for these children through this Global Grant.

Ellen Simon introduced our speaker today, Ms. Sheila Gutierrez, who presented, "Finding Peace in Anxious Times." She has been a Glendora Rotarian for the past 27 years.

As noted above, Sheila has 30 years of private practice working with individuals, families and group therapy counselling, and as a Critical Incident Debriefer – she had a handout we followed "referencing researched tenants of cognitive behavioral therapy" to help survivors, loved ones, first responders, and grief-stricken witnesses to cope with stress.

reducer. We all breathed together.

Her four points of recognizing and healing from trauma focused on her main observation: everyone has some trauma in their lives, and grief is to be acknowledged before it can be dealt with, "and the faster to get you to Normalization of what you are going through, the better the healing." She did warn us of the failure to work positively through trauma, that Acute Stress Disorder (ASD) is normal, but left untreated, can develop into PTSD, which does require serious treatment.

Our ancient ancestors survived by reacting to actual physical threats, and that stress creates real hardships to our bodies, taking days for our bodies to metabolize stress hormones – our kidneys and livers can't take stress for too long. She had a "Red reminder" – when you "see Red", which is a real thing, you must train yourself to breathe deeply. She led us in a breathing exercise, using all our lungs, as we counted to four, in and out. If you do this four times, it is a useful stress

And survivors' grief is real. She talked about grief and communal grief, like when we attend a funeral together, and how guilt and helplessness create that survivors' guilt (veterans know this feeling, and she helps them cope). Some people don't want to talk about this feeling but naming it will help overcome the guilt. And survivors' guilt can also bring up past traumas, too. Also, there is Secondary Stress – Caregivers, social workers, therapists, and emergency workers – and now with social media, there is no escaping the visuals and memories. Her advice is simple: less social media.

She finished by discussing the outcomes are pretty good eventually to those who acknowledge their stress and grief and work on taking care of themselves.

Our members had some observations themselves: Fire survivor Deb Lewis mentioned that there was lots of information and support for herself. David McAlexander noted that sometimes trauma can inspire to improve and thrive. And PE Hillary noted that her own son's Altadena friends' suffering made him feel survivors' guilt as he returned to college this past week.

PE Hillary closed the meeting by handing our speaker President Stephen's Magic Mug, with the magic of Rotary continuing for another week!


