Prior to that, Santamaria served in various roles at Univision Los Angeles, including director of local sales and senior account executive. Santamaria began her media career at Univision as an intern before being hired as a research analyst.

# Simply Stephen Smith's Spokes Speaks



Yesterday, March 20th, was the first day of Spring, which is also known as the vernal equinox. The first day of Spring is determined by where the Earth is in its orbit around the Sun.

On this day, the Earth's axis is not tilted toward or away from the sun. The earth's axis is tilted in such a way that the sun shines directly on the equator, thus creating a balanced division of day and night.

Once the Earth hits its vernal equinox, the Northern Hemisphere moves into spring and the Southern Hemisphere moves into fall. The Earth sits at 23.5 degrees on its axis, which is also what causes the seasons.

The vernal equinox is celebrated in a variety of ways around the world. In Japan, the

vernal equinox, or Shun-bun no Hi, is a public holiday to show appreciation for nature and welcome the start of the cherry blossom season. In addition, the country also recognizes a 7-day period called Higan, during which people pay respects to their ancestors.

In Mexico, one of the traditions is to visit the Pyramid of the Sun in Teotihuacan. Nowruz, meaning "new day", is a new year and spring equinox celebration in Iran and other countries in Central Asia. It is an ancient celebration of life, rebirth, and the triumph of light over darkness.

In the event anyone is wondering, there are 92 days in Spring as the summer solstice begins on Friday, June 20, 2025. The vernal equinox is also considered the beginning of the zodiac year in astrology. It's when the Sun enters Aries, the first sign of the zodiac, symbolizing new beginnings, action, and energy.

The first day of spring is a powerful symbol of change and optimism, marking the end of winter's dormancy and the start of a vibrant, life-filled season. As Pasadena Rotarians, let's celebrate this new season by energizing ourselves and do our best to help others less fortunate than us.





#### **KEY DETAILS**

Her main takeaway on hearing over ten years of Traffic Court is "when you get pulled over by a police officer, keep your mouth shut" – read on if you want to know more about Traffic Court FAQ's.

Many in the audience were drafted by song meister**Don Andrues** into the newly expanded Rotary Four-Way Test Singers, so when **President Stephen Smith** called the meeting to order at 12:30pm with the clang of the big brass Rotary Bell, a large circle of singers was ready to go with a legally inspired song (according to song leader **Eric Olson**), *I Fought the Law*, by Sonny Curtis of the Crickets – the audience followed the singers as we all happily sang about crime and punishment, the Rotary way!

- President Stephen Smith gave a summary of our Day of Service at the Altadena Fire Relief Effort last Saturday; Pasadena Rotarians attending were **President Stephen, Dean Billman, and PP Phil Miles**, and Rotary members of Claremont Sunrise, Altadena, Glendale, and Glendora clubs were also present. We gave away over 900 air purifiers, hundreds of bags of fruit and vegetables, and new donated clothes to over 700 cars of registered fire victims. **Dean Billman** got very sunburned.
- · Union Station Homeless Services, a Rotary corporate member, will have their annual fundraiser at the Rose Bowl on April 6<sup>th</sup>, taking the place of their Masters of Taste event our club is encouraged to sign up to volunteer.
- FIRE RELIEF CONCERT AT THE ALEX THEATER MARCH 27<sup>TH</sup>; Altadena & Friends is throwing an Altadena Fire Relief fundraiser at the Alex Theater, and the Altadena Rotary club is one of the organizers many of the musicians who lost their homes will be

performing, including one of our past Dan Stover violin judges, Ms. Irina Voloshina. They encourage us to buy tickets and support them. (see above information)

- **PE Hillary Schenk** promised to buy dinner for all Pasadena Rotarians who join her at the Rotary International Convention in Calgary, Canada on June 21-25. Many of our club members have attended in the past and can share wonderful stories of the event in the host country.
- **Mike Bernard** (chair of Dan Stover Music Contest Committee) announced the Dan Stover Regional Finals at the Pasadena Salvation Tabernacle on March 27th and encouraged our membership to attend.
- · Visiting Rotarian Robert Steel, from the Rotary club on St. Martin, and a summer resident of Wyoming, gave a Polio Pig announcement. He is working in Altadena representing a company which makes fire-proof and earthquake-proof building materials and has a business partnership with a former LA Fire chief. He is interested in joining our club!
- **Sandy Goodenough** (co-chair) reported on our club's Global Grants Project, *Speak Up for the Poor*, a Pasadena Rotarian's project in Bangladesh, helping young women avoid becoming child brides through school sponsorships we sponsored books and school supplies, helping many become nurses and teachers. **Gary Kearney** introduced our speaker today, his spouse PP **Mary Lou Byrne**, as an accomplished retired jurist, but also as someone who was born in El Centro, California's desert, without knowing what a forest tree or snow looked like. But instead of eating her own heart, she followed it to an early entertainment career; however, since she was mis-cast in the school exam play and bombed out, she attended Pepperdine business school, took a business law class, and decided then and there to become a lawyer.



Her early legal career, after law school and working at JPL for five years (putting herself through night classes), was working for a large and middle-sized law firm, finally making partner. She spent years driving downtown every day working as a lawyer while raising a family (Culture Alert: "Young people! – Back in the day we got into our cars, drove to offices where we got work done with other people, and we used to dress up for work"). We marveled how times have changed.

All this led to a coveted appointment to become an LA Superior Court Commissioner, initially handling small



claims, rent evicitions (called "unlawful detainers"), criminal and family cases. She spent the last ten years handling traffic court from all the jurisdictions north of the 10, west of the 605, south of La Canada, and east of the 134/210 interchange.

Then Mary Lou put on her figurative robe and proceeded to give us hard-won advice on how to work with the legal system that many of us may eventually interface with: A Traffic Infraction. She asked the audience how many of us had appeared before her, and no one raised their hand – but several volunteered their children had.

As she said, "Criminal court is where bad people are on their best behavior; Family court is where the best people show bad behavior. And traffic court is regular people mostly on their regular behavior."

Her most urgent request to begin her presentation must have been a real pet peeve of hers: "When you get a fix-it ticket, you need to go back to court to get it signed off!" She added that it must be signed by a police station, many which charge a fee – the CHP station will do it for free.

#### She proceeded to then give us Traffic Court FAQ's:

- 1. Keep your mouth shut!
  - 2. Don't engage.
  - 3. The officer must tell you why he/she pulled you over.
  - 4. Everything you say is written on the back of the ticket; you will be quoted in court.
- 5. Don't be afraid to sign the ticket.
  - 6. "Signing DOES NOT admit guilt."
  - 7. You must sign it or go directly to jail.
  - 8. "Don't be a jerk."
- 9. Mark the "respond by" date in your calendar!
- 10. Read the whole ticket, especially what you are charged with. All the statutes are online look it up!

#### **Easiest Options:**

- 1. Pay the ticket (and go to traffic school)
- 2. Hire a lawyer and let them worry about it (costs between \$100-200) (She then showed a picture of happy defense lawyers)

#### If you want to play the odds:

- 1. Appear in court and plead not guilty.
- 2. Consider Trail by Declaration
- 3. Don't copy a bunch of stuff from the internet.

#### Day of Trial:

- 1. If officer doesn't show up, case dismissed. You win!
- 2. If officer shows and you think you're guilty, change plea and ask for traffic school.
- 3. See if the officer is willing to amend to a non-point violation (really long odds). If all else fails and you go to trial:
  - 1. Be familiar with the statute you're charged with violating!
- 2. LISTEN TO THE OFFICER'S TESTIMONY and move to dismiss if appropriate.

#### If you remember nothing else from today:

1. Be courteous to everyone, especially court staff.

- 2. Keep your mouth shut and if you must open it, wait your turn and be sure to tell the truth.

It was a near thing, but Mary Lou finished at 1:29 and President Stephen had time to present her with her magic Rotary mug and announce next week's program before adjourning the meeting and sending us on our way.


