DAN STOVER INSTRUMENTAL MUSIC COMPETITION Chair: Mike Bernard - Co-Chair: Allison Burgos



Don't miss this week's program. Some of the most talented instrumentalists from our local high schools compete in this annual district wide musical scholarship competition. Cash awards will be given to the winner and runners up.

14 talented musicians were heard at the Audition Round that took place Thursday evening, 3/6/25 at 6:00PM in the chapel at the Salvation Army Tabernacle of Pasadena. The top 3 competitors will be heard next Wednesday, March 12th. Three

independent judges will select the winner, who will move on to the Regional final on 3/27/2025. The winner of the Regional Final will move on to District Final at the District Conference on April 12.

*Note: Our Club has produced more Dan Stover winners than any other club in the district.

HISTORY: Dan Stover Memorial Music Scholarship: The Rotary Club of Alhambra, in the year following the death of Rotarian, Educator and Musician, Dan Stover in 1997 established a Music Scholarship Program in his name. The program was proposed, organized, and championed by a new Rotarian, Christine Montan, who was Alhambra's first woman Rotarian. Ms. Montan recognized and appreciated the contribution that Dan Stover had made as a Rotarian, musician and person. From these beginnings, the Dan Stover Memorial Music Scholarship program, "graduated" into a District program. A generation of talented, young musicians have participated and had the opportunity, in the name of Dan Stover, to compete against their peers and earn funds to further their

musical education with the scholarship awards.

- If you complete TWO separate shifts, you will receive a **free ticket** to tour the Showcase House any day after 1:30 p.m.

If you'd like to volunteer, let our coordinator, Amanda Pumilia, know which days you're available for and which shifts you'd prefer. She will schedule your shift(s) and send a confirmation with the date and time.

Over one and a half million people visit our world-class LA Zoo each year, and our speaker today, Denise Verret, the CEO and Executive Director of the LA Zoo, sees her mission to promote "a just and sustainable world where people and animals exist together." Over 140,000 school group visits per year bring the students unique experiences and a connection to nature they cannot get anywhere else.

President Stephen Smith rang the loud brass Rotary Bell at 12:30pm and called the meeting to order by asking Song Meister **Don Andrues**, accompanied by pianist Ann Louise Christensen, to lead us in song – Don couldn't think of an zoo or animal song, but in honor of upcoming St. Patrick's Day he drafted a large rowdy crew of the Four-Way Test Singers to join him in a sea shanty song called "What Shall We Do with a Drunken Sailor" – the whole room sang lustily to the tune made famous by The Irish Rovers. Certainly got us into the mood!

Our inspirator was absent, and as everyone was in a rowdy mood from our song, they began loudly suggesting to President Stephen to "Just Inspire Us!" and other suggestions – the whole room was rowdy – but then **George Falardeau** stepped forward and asked us to think about the survivors of the Eaton Fire and to have a moment of silence for them and bow our heads. George must have experience with rowdy drunken sailors.



We had several special guests (all guests are special):

• **Howard Raff** introduced a soon to be inducted member, Ms. Sneha Villalva, a professional speech writer.

Sergeant at Arms Robert Lyons jubilantly introduced beloved now Honorary member Jane Waas, and her husband Curtis, and daughter Janine.

• **Robert Lyons** also welcomed his friend Dr. Aaron Levy, an M&A Strategic Business Development manager.

Announcements:

• **President Stephen** alerted us to the opportunity to directly help unhoused survivors of the Eaton Fires through the Union Station Service facility this, and every Wednesday, from 10am to 3pm.

• **President Stephen** asked how many members enjoyed the Speed Rotary event last week - and because it was popular, he wants to keep the event each month going forward.

• **PP Ken Joe**, Chair of the Nominating Committee, facilitated the voting of the three "at large" committee positions. The three members of our club selected were **Deb Raupp**, **Alan Schier** and **Michael Bernard**.

• **President Elect Hillary Schenk** asked for volunteers to represent our club at the Pasadena Showcase House for the Arts this April-May, with each full day of docent ushering at the house raising \$50 per person for our Club Foundation. Many of our members are involved, and this would be an excellent way to represent for Rotary (and a fun way to get to see the house for free). Your reporter's wife, Karen Billman, is also a

• **PP Phil Miles donated** \$50 to the Polio Pig to celebrate his famous professional singer daughter known as B. Miles for her fundraising concert in Brooklyn for Eaton Fire as reported in The New York Times on February 21st.

• **PP Mel Cohen,** a professional insurance agent, encouraged everyone affected by the wildfires to attend the meeting with the CA Insurance Commissioner at John Muir H.S. on March 15th; and if anyone needs help understanding their insurance policies, please see him.

• **Robert Lyons** is spearheading what was the Community Grants Committee – now known as the "Eaton Fire Relief Committee" – and he asked every table to take five minutes today and brainstorm ideas of the best way we can allocate the relief monies we have raised. A scribe at each table took notes: Our table thought that the immediate need might be legal advice concerning if the Altadena home owners' legal property titles are in order, especially since lawsuits and insurance payouts will be determined soon.



PP Justene Adamec introduced our speaker today, **Ms. Denise Verret**, and she was very clear on the LA Zoo mission in our busy world, and especially on the need to promote and sustain the world's wildlife for us all to enjoy. An Altadena native, personally affected by the destruction of the wildfires on so many of her friends and neighbors, Ms. Verret said that the city can rebuild, just like her work to rebuild natural habitats for her animals. Her presentation was centered around three themes: saving wildlife, enriching our local communities, and bringing students closer to the world of animals and nature.

Our LA Zoo is in the top 20 of our nation's zoos, with thousands of people visiting it every day. Funding is always



a concern, but the attendance and research income helps offset the city financing, and the fact that hundreds of students visit, volunteer, and even attend Zoo Summer Camp, helps incorporate its services and education into many young student's experiences with nature.

The zoo is very committed to bringing back endangered species, like the California Condor (almost extinct, now breeding successfully), the Baja Peninsula Pronghorn, and the Mountain Yellow-Legged Frog; the successful reintroduction in North America of the New Mexico Ridgenose rattlesnake, and the Giant River Otter, once extinct in Argentina but breeding in our zoo, soon to be re-introduced to Argentina. They partner with many other zoos to trade and mate different animals, hoping to stop extinctions – our



members were curious of recent efforts to re-create the Wooly Mammoth, extinct thousands of years ago – not LA Zoo work, yet.

The zoo is committed to Conservation and well-being through proper animal husbandry, medical care, and recent advances in animal health – actual human doctors volunteering time to operate on ailing wild animals, even eye doctors helping with animal vision ailments. This work fascinated students, and there is an LA Magnet High School on the zoo grounds, and some students may receive scholarships from the Betty White Animal Foundation for Animals.

One final comment on the Zoo was promoted in the media to use some of its open spaces to generate extra income through some kind of "Entertainment Venue" theme park, like Zip line tours or carnival rides – all rejected by serious zoo leadership dedicated to promoting a serious educational and sustainable environment where generations of curious and committed young people can learn of the wild world around them, right in their backyard.

Let's plan a Rotary Day at the Zoo!


