PAST PRESIDENT MARY LOU BYRNE "My Life in Traffic Court"

Mary Lou Byrne received a B.S. in management from Pepperdine University, and earned her law degree at the University of Southern California, where she was a member of the *Southern California Law Review* and an instructor of legal research and writing. Mary Lou practiced business litigation in Los Angeles for twelve years, first as an associate and then as a partner, with the law firm now known as Nossaman, LLP.

In June 2005 Mary Lou was elected a Court Commissioner with the Los Angeles Superior Court. She presided over criminal, unlawful detainer, and family law cases in the Pasadena Court for almost 19 years, with short stints in

the Alhambra and West Covina criminal courts. She spent the last ten years of her judicial career in Department M of the Pasadena Superior Court, hearing the traffic matters for most of the San Gabriel Valley. She was also a member of the faculty of the California Center for Judicial Education and Research (CJER), teaching new bench officers from throughout the state how to handle traffic matters.

Mary Lou has lived in the Pasadena area since 1980 and has a long history of community service. She is a two-time past president of the Rotary Club of Pasadena and currently sits on the board of the Pasadena City College Foundation and the Pasadena Showcase House for the Arts.

Mary Lou is married to fellow Rotarian Gary W. Kearney and has one daughter, Theodora Byrne, who is a Marine Corps veteran and psychotherapist in Portland, Oregon.

Simply Stephen Smith's Spokes Speaks

The LA County Council has created a *"NEW MAP*" of the burned structures in Altadena. Although some of Pasadena's burned areas have not yet been included, but will be added.

At this point in the aftermath of the Eaton Canyon fire, the Damage Assessment, Search and Rescue, Evacuation and Shelter, Rebuilding power lines, Repairing water

systems, and restoring communication infrastructure has occurred. The next steps will be

as follows:

1) Environmental Recovery and Restoration. Efforts will focus on replanting native vegetation to prevent further soil erosion. Wildlife Habitat Restoration will be important for maintaining biodiversity and ecological balance. Creating firebreaks and having controlled burns can help in preventing future wildfires from spreading easily.

2) Rebuilding Homes and Infrastructure. When rebuilding homes, the focus will be on fire-resistant materials, and creating defensible spaces around properties. Public works projects will focus on restoring roads and bridges and taking into account flood control measures.

3) Community Support and Mental Health. Mental health services are critical for residents who have lost a home, loved ones, or pets. Insurance companies and governmental agencies will need to assist residents with claims and financial aid. Local volunteer organizations (like Pasadena Rotary) have been and will be helping with cleanup, rebuilding and offering support.

4) Prevention and Preparedness for Future Fires. Educating the community about fire prevention and creating emergency kits. Upgrading firefighting technology and training makes us better prepared for the next fire. Establishing fire watch programs ensures a more resilient community moving forward.

5) Collaborating with Local, State and Federal Agencies There should be discussions about improving local zoning and building codes.

By focusing on these efforts, Altadena will not only recover from the devastation caused by the Eaton Canyon fire but also emerge as a more resilient community, better prepared for future wildfires.

Altadena Disaster Relief Distribution Event Saturday March 15, 2025 - 7:00 AM





Chair **Mike Bernard** (Co-chair **Allison Burgos**) remarked afterwards that "we had 14 really great young players audition, the largest field in many years, and we hope that our contest will be 'a destination competition' for local young musicians."

President Stephen Smith rang the big musical brass Rotary Bell at 12:30pm and introduced **Jonathan Edewards** as our song leader today. He challenged us to join him, singing ABBA's



"Thank You for The Music" – with heartfelt lyrics of how music rewards both the artists and the audience. **Deb Raupp** dedicated her inspiration to our three musicians today, calling them "all winners already", for their dedication to their craft and performing in front of our audience. She then reflected how music moves and adds to our lives, through live music today, or our playlists during the day.

Sunday. She encouraged us to join President-Elect Hillary Schenk and others from our club to attend, especially because we need to attend the District Grants training to become eligible for District Grants for a project of our choosing.

It was time for one of our Pasadena Rotary signature annual events, The Dan Stover Instrumental Music Competition with Chair **Mike Bernard** and Co-chair **Allison Burgos**. The Dan Stover Memorial Music Scholarship was created by the Alhambra Rotary in 1997, to honor the beloved member with a Music Scholarship Program in his name. We now have a District-wide contest, with the winner of participating clubs going to a final contest at our District Conference in May. Each contestant at the club level and then the final event all receive Rotary Club scholarship checks.

Our esteemed guest judges:

 Victoria Sabonjohn (right in photo) is a professional freelance oboist and educator in the Los Angeles area. She performs actively in the Los Angeles area, playing with several local orchestras and chamber groups. Recent performances include the Los Angeles Philharmonic, Long Beach Symphony, and Santa Cecelia Orchestra.

• Vincent Houser is a Professor of Music and professional violinist. He also founded Art Deco Entertainment, an American Dance orchestra featured in motion pictures.

• Cathy Chan Biagini *(left in photo)* is a professional cello player, who has played with Yo-Yo Ma, Itzhak Perlman, Pinchas Zuckerman, and Mstislav



Rostropovich. She is currently the principal cellist of Thousand Oaks Philharmonic, Burbank Philharmonic, as well as with Pasadena Symphony Orchestra.

Our contestants:

• **The 1st place winner was Rio Navarro**, *(photo: right)* who played the Accordion. The piece was "Csardas", by Vittorio Monte.

• Feelings: Assertive keyboard and seemed to play both sides of the multi-keyed and buttoned instrument with different melodies – his playing and intonations, he seemed to be weaving haunting yet familiar melodies. The room was rapt with attention as we watched him play an instrument we were not familiar with, yet his mastery of the sound and tone was amazing.

• Notes: "Rio wants to bring the accordion back into the American music scene." He practices over an hour each day, and more before competitions, and likes to use music to express himself.

o Rio will represent our club in the 2025 District Conference competition.

• **1st Runner-up was Kimberly Tsou**, who played the Flute Concerto, 3rd Movement by Jacques Ibert.

• Feelings: Her crisp dexterity on the flute, with difficult chromatic runs, showed wonderful control of depth and "voice". Flowing notes and colorful interpretation brought visions of forest glens, babbling brooks, soaring butterflies and woodland frolicking. She was very sure of herself and enjoyed playing for us.

• Notes: Kimberly came to America in θ^{h} grade from Taiwan, and had a tough time learning English, but found her best way to express herself was through her flute playing.

• She practices four hours a day – two in morning, two in afternoon. She said that she also spends time on You Tube watching others playing flute and learning different


techniques.

• **2nd Runner-up was Haydn Schlinger.** He played the Polonaise in C Sharp Minor by Frederick Chopin.

• Feelings: He was very confident on the keys, pausing and floating for affect, and his choice was a real crowd pleaser. His phrasing and entertainment with the piece were enjoyable.

 Notes: Haydn was taking piano lessons at age four, and his parents hoped that he would grow into enjoying it – but he picked up violin on his own because he liked how it was a different way to make music.

• He attends the Pasadena Conservatory of Music.







While we were waiting for the judges' decision, we learned each student's name, school, and their musical aspirations. Our club was fascinated with the accordion and Rio's dedication to it – every question was centered on how it works and the function of the buttons – and Rio answered with great authority, "the bass buttons are pretty straightforward – they are grouped by 5ths chromatically, with major and minors in 7ths." **PP Phil Miles** asked Rio if he could teach him how to play!


