

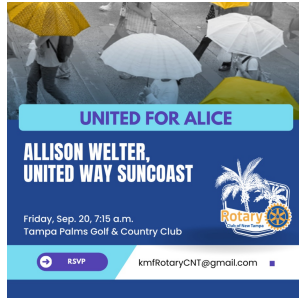

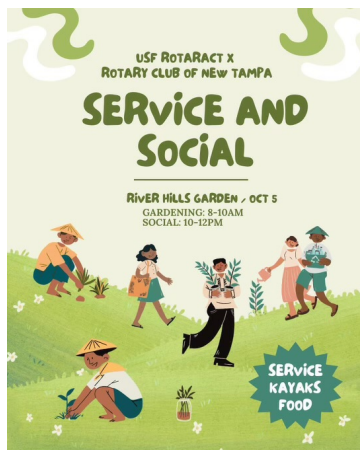
**Wiregrass Turkey Trot Costume Fun**

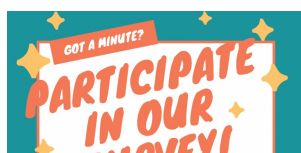
