

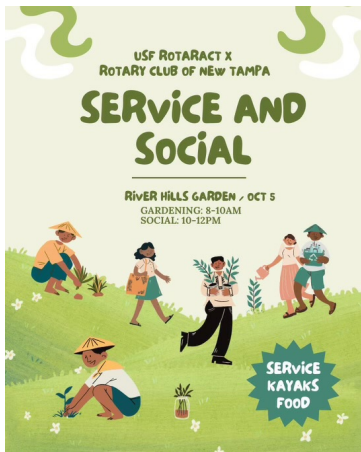


Wiregrass Turkey Trot Costume Run


