### Background:

Thanks to the approach we had through the 2nd. Meeting Pillars of Positive Peace, we detected the importance of incorporating the Pillars of Positive Peace into the civil society agenda, as a trigger to boost social projects and enhance their impact. Being the pillars selected to work through our proposal: Acceptance of the rights of others, High level of human capital and Equitable distribution of resources.

### Problem Description:

There are two common concepts of peace, each of which has a long history in studies on the subject: Negative Peace and Positive Peace. The definition of the Institute for Economics & Peace (IEP) of Negative Peace is the absence of violence or fear of violence. It is an intuitive definition that many agree with and that makes measuring peace easier. In the preparation of the Peace Index in Mexico (IPM), the Negative Peace measurements have been used.

For its part, the most ambitious concept of peace is that which corresponds to Positive Peace. "Positive Peace refers to the attitudes, institutions and structures that create and sustain peaceful and prosperous societies, with greater resilience and ability to face and resolve their conflicts through non-violent means." Positive Peace can be considered to offer the necessary conditions for adapt to changing contexts, have a well-run society and resolve conflicts without violence.

Mexico ranked 62nd out of 163 countries in the Positive Peace Index (IPP) 2018, ranking 40% higher globally. However, being ranked 140 in the Global Peace Index (IPG), Mexico was one of the 25 least peaceful countries in the world in 2018. When comparing the high levels of Positive Peace with those of negative peace, it is appreciated that







Mexico has the potential to reduce its level of violence if it overcomes some key challenges.

Although Mexico exceeds the global average in five of the eight pillars, it is currently below those levels that correspond to: 1) Corruption; 2) Good functioning of the government; and 3) Free flow of information. However, The pillar whose performance represents the most inefficient in the case of Mexico is "low levels of corruption", which is strongly correlated with peace in all regions of the world. A high level of corruption is characteristic of countries with a low level of peace. This is of special importance to better understand the dynamics of violence in Mexico.

The Positive Peace Index (IPP) 2018 indicates that countries that managed to significantly reduce violence and improve their level of peace developed several actions in common, such as reducing corruption, limiting citizens' access to small arms and firearms light, as well as improving institutional performance, access to information and the material well-being of society.

The current paradigm of peace and security is linked to reaction and containment through the public force, the criminalization of disadvantaged social groups and punitive and condemnatory laws. Our vision is different, we focus on the construction of positive peace, through the awareness of human rights, the reconstruction of the social fabric and the visibility of the "other" as a human being, with rights and opportunities. In this sense, the consolidation of alliances between social actors and Rotarians as agents of change, from the approach of peace building, opens the possibility of carrying out coordinated actions at different levels that allow breaking the vicious circle of violence and crime. , thanks to the generation and evaluation of integral projects that contribute to Peace, strengthening the social fabric towards the common good with an inclusive, respectful and supportive development.

### Justification:

Social actors have limited capacity to develop actions to promote social cohesion and social capital of groups and regions that live in situations of vulnerability and exclusion. On the other hand, an interest in increasing the level of involvement by Rotarians in actions aimed at social development, however there are few or ineffective mechanisms that allow adequate articulation between the actors. The foregoing justifies the need to strengthen the joint participation of social actors and Rotarians to achieve common goals. Likewise, the limited resources for carrying out actions by social actors, translates into different problems that form a vicious circle





that limits the professionalization of social actors and discourages citizen participation.

The strategic lines of REDECIM are: Collaborative work, knowledge of OSC'se social innovation, generation of synergies through the pursuit common objectives, professionalization, direct impact on of the Sustainable Development Goals and systematization of experiences. Currently, REDECIM is the first network in Mexico that contributes to the contribution and optimization of financial, human and technical resources of the International Cooperation for the Development of Civil Society Organizations at the national level.

Thanks to the approach we had through the 2nd. Meeting Pillars of Positive Peace, we detected the importance of incorporating the Pillars of Positive Peace into the civil society agenda, as a trigger to boost social projects and enhance their impact.
