## Rotary Recap

The meeting was opened with a clang of the bell by Prez Michael Soden. After our members and guests enjoyed their breakfast and fellowship, the pledge of allegiance was recited.

Dick Dailey, our meeting's sergeant-at-arms, introduced our guests, visiting Rotarians, and our program speaker, Pam Noyes. Beau Johnson, a Rotarian from Hamilton, Montana, was introduced. Green Valley H.S. Student, Sophie Arrowsmith and her parents, Ian and Wendy were introduced along with GVHS Principal Dave Chase, whose application for membership is pending. Robert Dworkin, and guests Jeff Horn and Genevieve Hayman were welcomed.

Next on the agenda were announcements: Prez Michael noted we have a busy weekend coming up! The District 5300 Luau was scheduled for Friday, September 13, and Rotarians were encouraged to meet District Governor Miles Petroff. Spousal coverage will no longer be available. Notably, large entities, such as MGM Grand, University of Virginia, and Xerox are all cutting benefits in order to meet the mandates. Many employers are cutting employee work hours down to 29, or less per week, to avoid paying Obamacare on "part time personnel". 7-Eleven is now classifying its employees as "independent contractors." Pam said that 71,000 people are uninsured within the State of Nevada. A \$95 per person penalty will be assessed to each worker who does not carry health insurance.

Last on the agenda was the raffle, and Jim F.'s number was called. Luckily, he drew a "Queen," leaving the bulk of the Pot intact. The meeting ended with Jim leading our group in reciting the Four-Way Test.
