## This Week's Program



Presenters Eric H. Franklin, Director of the Small Business & Nonprofit Legal Clinic and his student Michael Alires.

Professor Franklin joined the Boyd School of Law in 2013 after completing the Whiting Fellowship at the University of Denver Sturm College of Law. He directs the Small Business & Nonprofit Legal Clinic and teaches Business Planning, Corporations, and Contracts.

He received his J.D. from Cornell Law School and his B.A. from the University of Texas. After law school, he joined Sullivan Cromwell's corporate group in Palo Alto, where his practice primarily focused on mergers and acquisitions, corporate finance, and securities offerings. After several years at Sullivan, he moved to Seattle to join the business transaction group of Davis Wright Tremaine. At DWT, he worked on a wide range of projects, from documenting multi-billion dollar joint ventures to counseling entrepreneurs on legal issues facing early-stage companies.

The Small Business & Nonprofit Legal Clinic, which launches in the fall of 2014, will represent nonprofits, small businesses, and community-based associations on transactional matters. Professor Franklin's research interests include contract law, economic development, securities law, and corporate law.

He jumped into action and identified that one accident victim was in full cardiac arrest. Lockwood broke through the windshield to get to the man, and he was able to perform CPR and resuscitate him. Happily, the man has fully recovered thanks to Firefighter Lockwood's actions. Robert accepted the perpetual SOAR trophy and certificate graciously. He stated that he doesn't expect recognition for his actions. His wife Shelly proudly looked on as Club members gave him an enthusiastic standing ovation.

Gerry Holinski introduced guest speaker Dan Pentkowski who recapped the great job the Henderson Professional Fire Fighters are doing for our community. A detailed bio was in last week's newsletter. Club members were pleased to learn that cardiac arrest survivability in Henderson is three times the national average, and 911 calls receive a four to six minute response. The Department has brought on their own Hazardous Materials team, and The Department continues to be proactive in the community with their "Safe Pools Rule" and "Heat Kills" campaign. President Jack thanked Dan for his informative talk and presented him with the customary official Rotary pen.

The meeting was adjourned at 8:15 with recitation of the Four Way Test led by District Governor Larry Skaggs.
