Presenter: Tina Quigley, General Manager Regional Transportation Commission of Southern Nevada

Program: Update RTC Southern Nevada

BIO:

Tina Quigley is the general manager of the Regional Transportation Commission of Southern Nevada (RTC). She oversees one of the few agencies in the country that is

responsible for public transportation, roadway planning and funding, and traffic management all under one roof. Under Quigley's leadership, the National Transit Database named the RTC the most efficient transit provider in the nation and the agency is quickly becoming one of the most effective transportation organizations in the country due to its strong partnerships with both private and public sector organizations.

Quigley is known for her positive energy, passion and commitment to making Southern Nevada a vibrant community. Her strong leadership, clear vision and collaborative spirit led to the passing of bi-partisan legislation that has indexed Clark County's fuel tax to inflation for a three year period. This effort will generate up to \$700 million in revenue to fund 185 regionally and locally significant transportation projects and help create thousands of jobs in Southern Nevada.

Under Tina's direction, significant enhancements have been made to the RTC Transit system, improving workforce mobility and accessibility for our 2 million residents and 40 million visitors. In the last several years, the RTC launched eight bus rapid transit and express routes and a new residential route, and introduced a transit pass program for university students. In addition, the RTC built three transit terminals with commuter park and ride facilities, a LEED-certified transit hub in downtown Las Vegas, a first-of-its-kind traffic management center, and a second bus maintenance facility.

Prior to being promoted to general manager in 2012, Quigley served as the deputy general manager of the RTC since 2005. She holds a Bachelor of Science degree in Aviation Business and Planning from Embry Riddle Aeronautical University. She has a private pilot license and is a member of the American Public Transit Association. Tina also serves on the Luminous Park Advisory Committee, the Fulfillment Fund and the Las Vegas Convention and Visitors Host Committee.

Tina and her husband, Dale, have two children, Alyssa and Aidan.
