-May 14-17 is the District Conference to be held at Green Valley Ranch. As the conference will entail a celebration of District Governor Larry Skaggs' year as District Governor, all GV Rotarians are encouraged to attend!

-May is also a busy month as our club's Annual High School All-Star Seniors Soccer games will take place then. The specific date is to be announced.

-In addition, the Silverado and Green Valley High School Dan Stover Music Contest began this week. Regional Competition will follow in April and the finals will occur at the District Conference.



Brian Whitaker introduced our program speaker, Tina Quigley, General Manager of the Regional Transportation Commission of Southern NV. Ms. Quigley gave us an update of the RTC of Southern NV from her previous talk, presented to our club about two years ago. The National Transit Database has named the RTC the most efficient transit

provider in the nation. The agency is quickly becoming one of the most effective transportation organizations in the country due to its strong partnerships with both private and public sector organizations. Recently, there has been a passing of bi-partisan legislation that has indexed Clark County's fuel tax to inflation for a three year period. This effort is expected to generate up to \$700 million in revenue to fund 185 regionally and locally significant transportation projects which are expected to create thousands of jobs in Southern Nevada.

Significant enhancements have been made to the RTC Transit system, improving workforce mobility and accessibility for our two million residents and 40 million visitors. In the last several years, the RTC launched eight buses, rapid transit, express routes, and a new residential route. RTC also introduced a transit pass program for university students. In addition, the RTC built three transit terminals with commuter park and ride facilities, a LEED-certified transit hub in downtown Las Vegas, a first-of-its-kind traffic management center, and a second bus maintenance facility.

Last on the agenda was our raffle, and guest Derek Uehara's ticket was called. Luckily for all of us, he did not draw the Joker, and there is now one less card in our deck. The meeting ended with the recitation of the Four-Way Test, and the clang of the bell.
