Program: Nevada Rotary Foundation, update

Susan Holland Johnson is a "near native" of Las Vegas, having moved here in 1963 when she was 4. Her father was a firefighter with the City of Las Vegas Fire Department for 33 years before he retired in 1997. Her mother retired from her employment at University Medical Center in 1998 after working there for 20 years.

Susan grew up in Clark County, Nevada with her two younger brothers. Susan attended Paradise and Whitney Elementary Schools, Lyle W. Burkholder and Hyde Park Junior High Schools, and graduated from Ed W. Clark High School in 1977 with High Honors. She then attended and graduated from the University of Nevada, Las Vegas (UNLV) in 1982, acquiring a Bachelor of Science degree in Business Administration, with dual majors in Public Accounting and Investment Finance.

After graduating from UNLV, Susan attended and graduated from the University of the Pacific, McGeorge School of Law in Sacramento, California in 1985. While in high school and college, she worked full-time for Cochrane, Lehman, Nelson & Rose as a runner, McDonald's Restaurants as crew, Crew Chief and Shift Manager, and for the State of Nevada at both the Welfare Division and UNLV.

From law school, Susan became associated as an attorney (and subsequently shareholder) with Rawlings, Olson & Cannon (1985-1992), an attorney with Piazza & Associates (1992-1994), and then started her own practice in 1994, The Law Office of Susan Holland Johnson. She was first elected to the bench in 2006.

Susan and Eric Johnson have been married for 27 years, and they have two daughters: Tess and Emma. Tess recently graduated from UNLV's Boyd School of Law, and Emma is a rising senior at the University of Kansas. Susan and Eric co-chaired the Green Valley High School (GVHS) Women's Team Volleyball Program (including selling ads, compiling player stats, taking photos, etc), a task they did for almost 10 years. Additional community activities include membership in a number of organizations. Susan currently serves as Foundation Chair, at both the District 5300 and club levels, for Rotary International, and is also a past president of the Rotary Club of Green Valley. She is also President of the Howard D. McKibben Chapter of the American Inns of Court.

Past Pres. Dr. Jim F introduced the day's



speaker, Barbara F. Atkinson, M.D., the founder and planning dean for the new UNLV Medical School. Dr Atkinson began by enumerating some of the most pressing needs for a medical school in Southern Nevada. Nevada is 45 th in the nation in number of doctors per capita; 50th in the number of psychiatrists. There

are long wait- times for medical care. Some diseases simply are not treated here. Las Vegas is the largest metropolitan area in the country without a traditional medical school. UNLV Med will be recruiting in 2016, beginning with a first class in August 2017. It will first open with 60, expand to 120, then to 180 students. There will be a 120 mrmber faculty.

Partners for UNLV Med will include UMC, the VA, and other hospitals such as Sunrise and St. Rose . The Academic Health Center will partner with a number of other health care resources in the community, including the Henderson area clinic. Educational and research programs will include cardiology, mental health, neuroscience, cancer, and orthopedics. Guiding principles will include the selecting of students who will commit to stay in Nevada to live and practice, a diversity of background, doctors for urban practice, problem and team-based education, classical history and physical examination processes, coupled with genomics and advanced technology. Special programs will be community and public health, clinical research, bioethics, business and finance, leadership, and community service.
