Rotary Recap: March 3, 2016

A lightly attended breakfast meeting of the Rotary Club of Green Valley (RCGV) was launched by President Duane Frizell at the Wildhorse Golf Club last Thursday, giving the members an opportunity to catch up on the upcoming service projects. During the Club Assembly, the Club's Board Members reported on past successes, as well as future social and civic functions.

New member Stacey Mulligan introduced our guests before Pres Duane began announcements by passing around a signup sheet for the expanded, upcoming Bike Rodeo at Robert Taylor Elementary. A District Grant has enabled RCGV to broaden the experience for the low income children at Robert Taylor Elementary. More club members are needed this year for the March 18th event. The first shift is from 8:30 a.m. to 11:30, followed by a second shift from 11:30 to 2:30. The grant will enable RCGV to provide helmets for 148 participants and basic parts such as brake shoes will be available to prepare the bikes so that the economically disadvantaged children can proceed safely through the training course. Henderson Rotary has offered to assist with the Bike Rodeo and with some of the mechanical fixes. It is hoped that Walmart or Costco will come through with some new bikes to be given away, which will create more excitement for the Bike Rodeo among the students.

Board Member Dave Jochman reminded us that the first Friday of the Month is our monthly Rotary Roundup Social. Members, family, and friends gathered at the Black Mountain Grill on South Eastern for food and beverages last week.

Foundation Chair Susan Johnson stepped up to the microphone to introduce the Club's newest Paul Harris Fellow, Dave McGovern. Dave has assisted the Club financially and with many service projects. Recently he provided printed certificates that honor the winner and runner up for the Dan Stover Music Competition. Dave received a standing ovation from the Club.

Trivia Master and Happy Bucks Host Mike Peterson stepped up with trivia celebrating another obscure holiday, National Anthem day. Francis Scott Key was recognized for writing the song, and we learned that it was adopted as our national anthem in 1931. Few members knew that the song has four verses.

Delinda Crampton had a happy dollar celebrating that she has been named one of the Valley's top 25 realtors. Past President Jim Frey had a sad dollar over the loss of former member Tom Bramlett. Dave Jochman had a happy dollar for having had the opportunity to conduct Bramlett's funeral services.

New officers were introduced by Pres Duane. The replacements were the result of recent resignations and relocations. Greg Bruce was introduced as the new Club Secretary, and Brad Marx has agreed to fill the Treasurer's position. Jerry Gardberg has been named the new sergeant at arms, but unfortunately, Judy Lloyd reported that Jerry has been hospitalized and is undergoing back surgery.

Board Member Jay Larsen has agreed to be Projects Chairperson, succeeding Pres Duane. Jay reminded the Club that the Bike Rodeo is the RCGV's next big project. Plans are starting for next year's Southern Nevada High School All Star Game, Santa Hoolihan's appearances, and for Cards and Dollars for the Homeless.., Jay informed the members that the Teacher Grant Program has generated applications for RCGV funding, and the teachers will attend the RCGV meeting to receive their grants on April 14th.

Publicity Chair Art Macarios reported that his efforts to gain newspaper coverage for Club events has not been successful. It was recommended that Bike Rodeo Volunteers wear Rotary Identification, and that Art try to get newspaper coverage for the event .

Pending member Dan Stock announced the Eighth Annual "Easter Walk n' Roll". The Easter Seals sponsored event is Saturday, 11:00 a.m., March 26, at Lorenzi Park. Bring your kids to see the Easter Bunny! Dan informed the audience that the Easter event is sponsored by Rotary International. Easter Seals was actually originated by Rotary nearly 100 years ago.

RCGV's Youth Programs are continuing, and according to Local coordinator Jim Frey, last week's speech contest winner will progress to regional competition in late April. Jim told us that Silverado and Green Valley HS 's are currently preparing essays for the approaching essay contest. Jim Paxton reported that a clarinetist from Foothill High School won the local Dan Stover competition and that the regional competition will be held at Anthem Country Club, April 3, 10:00 a.m.- noon. Jim urged Club members to attend and watch these talented Southern Nevada youngsters perform.

Foundation Chair Susan Johnson reported that RCGV will probably once again qualify as a 100% Paul Harris Member Club, but member changes have made it a challenge. Susan said that there is some challenge for RCGV to meet its Rotary International Pledge, but that the Club is well on its way to meeting its Polio Plus Pledge. She is looking to fill an opening on the Club's Foundation Board that meets the first of each month.

Charity Chair Mike Soden told the Club that the Souper Bowl Food Drive is still in the works. Albertsons was undergoing changes on Super Bowl Weekend, and the Club has still been unable to secure food collecting locations. Negotiations have resumed with Albertsons and the Club is also talking with Whole Foods. Last year the food drive resulted in nearly two pickup truck loads, which were then delivered to the Henderson Food Bank.

Mike S. told us expect a Thursday program in the spring where many of those receiving RCGV funding will appear as a meeting program, as they did last year. Interact Chair and incoming President Bob Hulshouser reported that Interact is thriving at both Silverado and Green Valley High Schools. The Interacts are combining to buy a Shelter Box for an international project. Bob also said that a Rotaract, college- level club is in the works at Nevada State College.

Treasurer Brad Marx conducted the raffle, and the ticket, held by Susan Johnson was selected. Susan drew a nine from the deck to win \$9. The lengthy Club Assembly meeting was adjourned about 8:20 a.m.
