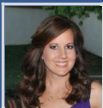

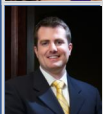

plan was adopted in 2006. "With the economic recession and associated economic effects, this is an important time to evaluate the City's vision and to keep Henderson an attractive place for residents, students, and businesses," explained Garcia-Vause.

Additionally, Henderson seeks to align local plans with the recently completed Southern Nevada Strong Regional Plan to ensure competitiveness for implementation funding through local, state and national sources. Henderson also aims to customize their strategies to better connect housing, transportation, and jobs at the local level in ways that work for our unique community.

Forth of July Summerlin Parade Offers an Opportunity for Service, Paul Harris Credits, and Balloon Wrangling Fun

July 4th is soon upon us, and RCGV members have an opportunity to put "Service Above Self" to work, for yourself and for the Club.

Monday July 4th is Independence Day to some and "The Summerlin Council Patriots Parade" to others. This day provides the chance of a lifetime to be a "BALLOON WRANGLER". As a balloon wrangler, you will get to tether a parade size balloon much like the Macy's parade balloons that you see on TV, just slightly smaller.

Participants will earn \$40 towards a Paul Harris Fellow Award, to be given to each participating Rotarian. A non - Rotarian Volunteer will earn the same \$40 as you towards YOUR Paul Harris Fellow Award. All that is required to earn the \$40 donation to Paul Harris is to give a part of your July 4th Morning to the balloon wrangling duties.
