The regular Thursday breakfast meeting of the Rotary Club of Green Valley (RCGV) was called to order at 7:15 a.m. by President Duane Frizell, following breakfast and fellowship at the Wildhorse Golf Club. After the Pledge of Allegiance and a moment of silence for reflection, Pres Duane called on Membership Chair Debbie Mitsch to introduce the guests and visiting Rotarians.

Visiting Rotarian and prospective member Robin Mondel has moved to Henderson from Cheyenne, WY. Anthony Rocchio, a guest of Gerry Holinski, and Green Valley High School Assistant Principal Paul Fagone were also welcomed.

Announcements followed with a request from Pres Duane for members to make up missed meetings either at another Club or on line. It is hoped that we can boost our attendance. Pres Duane asked that members note that dues are due. Next he thanked new members Christina Tomlinson and Greg Bruce for handling the greeting and attendance. Christina has volunteered to assist in coordinating the weekly host duties. The District 5300 Annual conference will be held this weekend in San Diego, and members were reminded that RCGV's contestant, Madeline Andrew, will compete in the Four Way Speech Finals during the District Conference, hoping to win the \$5000 grand prize. Debbie Mitsch urged attendance for the new member meet and greet fiesta, which was held last Friday evening, with about 40 Rotarians and spouses attending, at Debbie and Husband Bob's Anthem home.

Rotarian of the Year Ballots were passed out, and they are available on the Club's Website. Check the calendar at the left of this bulletin for the dates and times of other upcoming events including the Triathlon for kids. In the absence of Mike Peterson, Past President Jim Frey hosted Trivia and Happy dollars. In recognition of National Nutty Fudge Day, the trivia stumper was the name of the first candy bar. No one knew the answer, the Cadberry bar. The country consumes seven billion pounds of candy per year. The original name for the Sugar Daddy was the "Papa Sucker."

A happy dollar came from Heidi Woodruff, whose son is celebrating his 20th birthday. Gerry Holinski was happy to be joined by visitor Anthony Rocchio, a local developer. Dave Jochman happily reported on the successes of his daughter, who is the only female among 500 males at Army Base Ft. Irwin. Guest Robin Mondel was happy that her son is now 40.

Ken Stock was happy that his daughter is getting married, and the couple will be moving to Arizona where his new son-in-law will be going to grad school. The returning Melinda Margolis had a happy dollar for the experience of judging Interact business projects with Bob Hulshouser at Silverado High School. Pres Duane had a dammit dollar because he had to miss Debbie's Meet and Greet, due to a pre-commitment to take some scouts camping.



The day's program was the annual charity breakfast, and Charity Chair Mike Soden went over where the Club spent its money during the current 2015-'16 Rotary year. Mike also summarized the interchange with RCGV's Non Profit Foundation. The Club is looking for new fund raising opportunities. Currently, our biggest money raiser is our Fall Gala, which last year raised \$16,000. \$12,000 of the Gala returns went to the RCGC Foundation and \$4,000 went

to the Club's treasury.

"When I became active with RCGV, our treasury held about \$15,000. The goal was to spend it down to about \$10,000, but our balance remains above that at about \$12,500." Mike showed a power point that listed the Club's major expenditures.

- \$ 2,150 To GVHS, and beginning this year, \$2,150 will also go to support Silverado High School

- \$ 1,000 For Santa Hoolihan

- \$ 500 For the Henderson Food Bank

- \$ 1,500 Was budgeted for the Dan Stover Music Contest, the Four Way Speech Contest and for the Essay Contest.
- \$ 400 goes toward the Corazon SuperBuild
- \$ 400 is budgeted for the Rotaplast, Cleft Palate Program
- \$ 700 was earmarked for the Southern Nevada Association of Polio Survivors (SNAPS)

Mike and Jim Frey explained that the High School All Star Soccer Game, which the Club has sponsored for many years, has netted \$1,400-\$1,500 in the past, but because of the intervention by the high school authorities, the event lost money last year. Other budgeted items include funding for local teacher grants, where ten to eleven local teachers receive grants up to \$250 for their classroom programs.

The membership was shown how to locate RCGV's Charity Application at the drop down, top right, of the Club's Home Page. Those who wish to be considered for RCGV funding need to fill out the application and submit it to the Charity Committee, which meets monthly.



The final item on the agenda was the presentation of a check to Assistant Principal Paul Fagone, for the funding of Silverado H.S. programs. With his gracious acceptance of the check, Paul expressed how appreciative Silverado is for RCGV's support.

Treasurer Brad M. had Mike S. draw a raffle ticket after his presentation. Dave Jochman held the ticket and he did the right thing, pulling an ace to win \$1. Jim Paxton was called on to ring the closing bell.
