### Shoes for Orphan Souls District Shoe Drive



Shoes for Orphan Souls is a collaborative service project between Buckner International and Rotary District 6670. We have been providing shoes and socks for 8 years for children living in orphanages and impoverished communities where Buckner provides a variety of holistic services. Our Shoe Drive was very successful last year. We collected over 1500 pair of shoes and close to 1000 pairs of socks. We want to increase that number by 20% this year. Last year the Williamsburg Club collected 201 shoes, 31 socks, and 50 shoe laces. What Club will out do them this year?

So rally the troupes and get busy collecting shoes. Many Clubs have already begun the effort. We officially kick off the Shoe Drive in January when you will receive your Shoes for Orphan Souls Shoe Drive packet from Buckner, but you are encouraged to begin the process now. The culmination of the Shoe Drive is at the District Conference April 29th and 30th. Contact local businesses, churches, organizations, and schools within your community to join you in your collection. Utilize your Interact and Roteract Clubs to work with you.

We take shoes and socks for granted, but for many children around the world, they are a luxury. Shoes protect feet from diseases such as hookworm, which can lead to physical and cognitive development issues. Let's pull together and provide these much needed shoes.

# Dayton Rotary Celebrates Member's 100th Birthday



On Monday, January 4, 2016 the Dayton Rotary Club celebrated the 100th Birthday of long-time Dayton Rotarian, A.J. Bush who joined Dayton Rotary in June 1955 and served as Club President in 1965-66. The following was the tribute delivered by President Dave Williamson in recognition of A.J.

On January 6, 1916, when AJ Bush entered the world. Life expectancy in the United States for males born that year was only 49.9 years. AJ has doubled

that

In 1916, the Population of the United States exceeded 100 million for the first time. It has tripled in AJ's lifetime. When bouncing baby boy Alden J. Bush opened his eyes for the first time in 1916, he observed a world without many of the things Centenarian AJ Bush observes today. In 1916, there was...

- No television
- No radio
- No computers, no internet
- No jet airplanes
- No refrigeration
- No National Football League
- No Las Vegas
- No Disney Land, Disney World, or Disney anything
- No Academy Awards
- No plastic, zippers, band aids, Q tips, scotch tape, bubble gum, twist ties, deodorant, sun glasses, coolers, parking meters, or tow trucks, electric guitars, bulldozers, credit cards, spray paint, or cat litter...those all lay in AJ's future

In 1916 Telephones were rare, only about 8 people in every 100 had one Automobiles were rarer, only about 6 per 100 people, So, texting while driving was not an issue for the Bush family in 1916.

Like 2016, 1916 was a leap year and a Presidential election year.

Europe was at war, in what was then called "The Great War" but would later be called "World War I"  $\!\!\!$ 

Woodrow Wilson was President of the United States and would win reelection on the campaign slogan "He kept us out of war". But, not for long as the United States would enter the conflict shortly after AJ's first birthday in 1917.

In 1916, British Captain T.E. Lawrence, "Lawrence of Arabia", helped start the Arab Revolt against the Turks, which ultimately shaped the Middle East as we know it 100 years later.

And in October, 1916, an obscure German Corporal by the name of Adolf Hitler was injured in the war. If only...

#### Also in 1916:

- John D. Rockefeller became the world's first billionaire.
- The Saturday Evening Post published its first cover with a Norman Rockwell painting.
- The first published reference to a new musical form called "jazz" appeared in Variety Magazine.
- The final form of Einstein's theory of general relativity was published.
- In China, the last emperor in a line of rulers that stretched back over 2,000 years, abdicated his throne.
- and Jeanette Rankin became the first woman elected to the US House of Representatives. When AJ was 3 years old, Representative Rankin would be the only woman to vote in favor of the 1th Amendment to the United States Constitution, granting the right to vote for all women.

And in the Dayton Rotary Club in 1916, John Patterson, founder and owner of NCR, accepted honorary membership in the club and attended his first meeting. He later hosted the entire club at the Rotary international Convention held that year in Cincinnati.

AJ is not the only 100<sup>th</sup> year celebration in 2016.

The 100<sup>th</sup> running of the Indianapolis 500 will take place in May.

Also celebrating 100 years are:

- The National Park Service
- The Pulitzer Prize
- The Trans-Siberian Railroad
- Nathan's famous hot dogs
- The iconic Coke bottle
- The Professional Golfers Association
- And Wrigley Field in Chicago, where in 1916 the Cubs played the first game in the friendly confines and, you guessed it, defeated the Reds 7-6 in extra innings.

While AJ Bush is by far the most famous American born in 1916, also born that same year were:

- Comedian Jackie Gleason
- Pin-up girl Betty Grable
- Band leader Harry James
- Singer Dinah Shore
- Actress Olivia de Haviland
- Actors Gregory Peck, Glen Ford, Van Johnson, and also slated to celebrate his 100<sup>th</sup> birthday this year
- Actor Kirk Douglas

#### Also born in 1916 were:

- US Senator and Presidential candidate Eugene McCarthy
- US Secretary of Defense Robert McNamara
- Ohio Senator and US Attorney General William Saxbe
- And radio and television newsman, Walter Cronkite

And to paraphrase Mr. Cronkite: "And that's the way it was" 1916

Although AJ is the oldest member of the club, he is only the second longest serving member of the club. Bob Siebenthaler joined the club in 1953. AJ joined June 15, 1955, over 60 years of Service Above Self.

He was present at the Club's 50<sup>th</sup> Anniversary when surviving Charter Members James Woodhull and William Hatmaker were present, so you see, he represents our bridge to our Club's very beginning. This year marks his 50<sup>th</sup> anniversary as Club President having served in 1965-66. He has mentored and guided 50 presidents since then.

In addition to many other contributions to our community, AJ served as President of the Dayton Dental Society, and the picture of AJ and his lovely wife have greeted all of us at the airport for the past 12 years on the ad for Walnut Creek.

From my research as your club historian, today marks only the third time in club history that we have paused to celebrate the 100<sup>th</sup> birthday of one of our own.

I fully realize that we are not a singing club, but on this special occasion, I invite you all to please stand and follow former club President Charlie Campbell on accordion, in a full throated chorus of "Happy Birthday to AJ", and we will ask our birthday boy to blow out the candles on his slice of cake.

Following the singing of Happy Birthday and sharing of the birthday cake by all in attendance. City of Dayton Mayor, Nan Whaley read a proclamation to AJ naming January 6th as A.J. Bush Day in the City of Dayton.

A good time was had by all at the Birthday Party for A.J. and he informed his fellow Rotarians that "good clean living" was not necessarlily a factor to make it to 100 years young!



## Have You Adopted the New Rotary International Brand Standards on Your Club Website?



International has spent a great deal of time and money to develop a new branding initiative for clubs. The new logo, along with the new color scheme, have been heavily researched for maximum impact in local communities and around the globe. Presidents and District Governors have been charged with

encouraging clubs to adopt these new standards this Rotary year.

In March 2015, the Cincinnati and Toledo Rotary Clubs formed a partnership to create state-of-the-art websites which are responsive (smart phone and tablet friendly) along with adopting the new RI branding. The sites were developed by the Thread Group, which is owned by Joe Sharp, a 20+year member of the Rotary Club of Toledo. As part of the development of the two club sites, The Thread group created a template so other Rotary Clubs anywhere in the world could have their sites built on the same platform at a fraction of the cost. The site includes a link for members into Club Runner or DaCdb, a donation button, a Member Dues Payment option, a robust calendar, and so much more! So, here's the good news for your club! Together, Toledo and Cincinnati spent \$33,000+ to develop the template but the cost for other clubs to get the same website is only \$9,000. Of the \$9,000, \$1,500 goes to the Rotary Foundation of Cincinnati, \$1,500 goes to the Rotary Foundation of Toledo and \$6,000 goes to the Thread Group for the customization of a club's site. ## Troy Rotarians Tour St. Patrick's Soup Kitchen

The January 5, 2016 meeting of the Troy Rotary Club was held at the St. Patrick Soup Kitchen, located at 25 N. Mulberry Street inside the Hobart Community Kitchen in Troy. Hosted by owner/operator Dick Steineman, members were invited to tour the second floor and



basement to see the multi-purpose rooms and storage areas as they learned more about the facility. Opened in 2014, the building was made possible through the generosity of many businesses and civic leaders. Hobart Corporation donated funds and kitchen equipment, local builder Frank Harlow coordinated the construction while The Troy Foundation, other trusts and generous individuals helped ensure the project was completed.

Its' hours of operation are Monday-Friday, 5-6 PM, and they serve 450-500 meals each week. In addition to the weekday service, they send out meals to Troy's north side every Saturday evening and offer a special delivery service of over 2100 meals on Christmas Day each year. In all, the Soup Kitchen provides nearly 25,000 meals each year to area residents. The entire operation is supported through charitable donations of food and funds. With more than 150 homeless individuals in Miami County, Steineman works with other agencies to offer assistance to anyone in need. The Soup Kitchen is an important part in Troy's blanket of care, and the Mulberry Street door is always open to anyone or
