Dear Leavenworth Rotary Members,

Please note the dues information below and send your payment by check to our Club Treasurer, Shawna Alexander ASAP. The mailing address is Leavenworth Rotary Club, P.O. Box 532 Leavenworth, WA 98826. Thanks in advance for your prompt payment. Club dues fund the operation of our Club. The due date is the beginning of the Rotary Year: July 1, 20XX at which time Rotary International and the District levy their fee on our club based on the number of people who say they are Leavenworth Rotarians. Each member's annual dues are currently **\$250.00**. Dues are used to cover the cost of a (club) membership payment per person to Rotary International of **\$85.56** per year that includes a subscription for Rotary Magazine of \$12 per year.

In addition, dues are used to cover the annual per person obligation to District 5060 of **\$48.50**. That leaves our club with an annual per person amount of **\$115.94**. These funds are used to cover the costs of operating the club – licenses, bank charges, accounting fees, club supplies, Club Runner, printing, postage, guest meals, etc.

All Rotarians have an opportunity annually to contribute to the Rotary Foundation (TRF)* voluntarily and the Polio Fund.*. We respectfully request 100% member participation in RI's program named EREY (Every Rotarian Every Year) donating \$110 to The Rotary Foundation.

We also ask you to consider donating voluntarily and locally to our Jim Adamson Fund—we can spend this anytime; or our Leavenworth Rotary Ed Cadman Endowment Fund*, which can only be used in support of 501c3s. Contributions for either are recommended at \$40.00, which sums up to a total of \$150.00 when added to an EREY contribution. The Club has been successful in obtaining both District and RI grants, so dues sent to them do come back to us to support our local efforts.
