Dear Leavenworth Rotary Members,

Please note the dues information below and send your payment to our Club Treasurer, Shawna Alexander ASAP. The mailing address is Leavenworth Rotary Club, P.O. Box 532 Leavenworth, WA 98826. Dues can also be paid via electronic transfer or paid bi-annually **or via installments coordinated with Shawna**. Please talk with Shawna for more information (509-548-5231).

Thanks in advance for your prompt payment. Club dues fund the operation of the Club and allow it to continue. The due date is July 1, 20XX at which time Rotary International and the District levy their fee on our club based on the number of people who say they are Leavenworth Rotarians. Each member's annual dues are currently **\$250.00**. Dues are used to cover the cost of a (club) membership payment per person to Rotary International of **\$85.56** per year that includes a subscription for Rotary Magazine of \$12 per year. These RI fees have been fairly stable, but the fee tentatively will go up \$2 on 1 Jan 2023 and \$3 on 1 Jan 2024, and \$3 on 1 Jan 2025 to cover needed improvements in RI (marketing, communications infrastructure, etc).

In addition, dues are used to cover the annual per person obligation to District 5060 of **\$45.00**. Two Hundred Fifty less the two obligations (RI and District) leaves our club with an annual per person amount of **\$119.44**. These funds are used to cover the cost of operating the club – licenses, bank charges, accounting fees (software), club supplies, Club Runner, printing, postage, guest meals, etc.

The beginning of the Rotary year also marks the opportunity to again contribute to the Rotary Foundation (TRF) voluntarily—this and the Polio Fund are tax deductible. We respectfully request 100% participation in RI's program named EREY (Every Rotarian Every Year) donating \$110 to The Rotary Foundation. The remainder of the Club pledge not generated thru individual member contributions is taken out of the Club's general fund at the rate of \$110.00 per non-contributing member.

We also ask you to consider donating voluntarily and locally to our Jim Adamson Fund—we can spend this anytime; or our Ed Cadman Fund, which can only be used for charities or to support 501c3s (also tax deductible). Contributions for either are recommended at \$40.00, which sums up to a total of \$150.00 in addition to your due's payment. The Club has been successful in the past of obtaining both District and RI grants, so dollars do come back to the Club to support the Club's efforts.
