**Paul Harris Society (PHS) Eligible:** An individual who contributes US\$1,000 or more each year to the Annual Programs Fund. Contributions are cumulative throughout the Rotary year and donors may be eligible for special recognition administered by their Rotary district. Contributions count toward Paul Harris Fellow, Multiple Paul Harris Fellow, Paul Harris Society and Major Donor recognition.
