TWIN PEAKS ROTARY FAMILY MEMBERSHIP POLICY

Individuals may become eligible Family Members of Longmont Twin Peaks Rotary through our regular member approval process.

All Family Members will receive:

- Rotary International and District recognition as members
- Formal induction into the club
- Voting membership in the club
- Eligibility for any office in the club
- The Rotary Magazine (can request just one copy)
- All Rotary International, District & club emails and notices
- Recognition on all Rotary member lists and website
- Access to the Rotary website
- Rotary member badge & pin

The primary member who would receive:

- lunch prepaid.

The secondary member would:

- attend regular meetings and pay the current lunch fee.

Cost of Family Membership will be \$225 per quarter for the primary member plus \$40 per quarter for the secondary member. There will also be one-time initiation fee of \$70.00.

Family Membership may have additional members for an additional \$40 per quarter.

Additional members will be specifically named and can be anyone from the same family.

These additional members can attend any Rotary meeting, and are encouraged to participate in fundraisers, service projects and socials.

If these additional members may attend regular meetings, and will be expected to pay the current lunch fee.

Family Members may join the club as individual members at any time. Regular membership fees and initiation fees will be charged.

The process of termination of a Family Membership primary member or secondary members will be the same as for a regular member.
