Join us in the celebration of the Town of Oro Valley's 50th Golden Anniversary with the local Rotary Club at its 9th annual *A Taste of Oro Valley Life* (TOVL) event on Saturday, March 30, 2024, from 2:00 – 6:00 PM at the Oro Valley Marketplace. The theme of this year's fundraiser is *Helping Families* and the primary beneficiaries of the proceeds include Edge High School, Emerge and IMPACT of Southern Arizona. These nonprofit organizations address critical issues that families face such as high school dropout rates, domestic abuse, and stabilizing families and seniors.

We are looking for 15 restaurants and a mix of cuisines to provide a "taste" of their dishes for our estimated 500 attendees. Laramita Cellars Winery will be providing wine tastings and we'll be asking breweries to provide samplings of their beverages to attendees 21 years and older. Children will be entertained with a live petting zoo and other fun attractions and there will be a Silent Auction with wonderful goods and services from local businesses.

Deadline for restaurant/business commitment no later than January 31, 2024.

Restaurants are being asked to provide:

- A minimum of 300 food samples with serving plates/cups/utensils/napkins.
- Servers to give out the tastes. Up to three (3) servers will be provided with free entrance to the TOVL event.
- Please complete the Pima County Health Temporary Food Permit Application

 \$30. The Rotary Club of Oro Valley will reimburse the \$30 to the restaurant after
 the vendor has participated in the function.

This permit is only available online. If you do not get your application in by March 15, 2024 there will be a \$45 additional expediting fee (non-refundable).

- Promotional materials for their restaurant, including a current high resolution logo for the TOVL promotions.
- Restaurants can start setting up as early as 9:00 am on Saturday, March 30th; they must be set up by 1:00 pm for the Health inspection. Tear down will begin after the event ends at 6:00 PM on March 30th and must be completed that night.
- Restaurants are also asked to promote TOVL in their businesses using the promotional materials provided by the Rotary Club of Oro Valley.
- There is to be no exhibition cooking on site, and no open flames. Sterno flames are allowed.

Businesses are being asked to provide:

- Promotional materials for their business, including a current high resolution logo for the TOVL promotions.
- Businesses can start setting up as early as 9:00 am on Saturday, March 30th and can start tearing down after the event ends at 6:00 PM on March 30th and must be completed that night.
- Businesses are also asked to promote TOVL in their establishment using the promotional materials provided by the Rotary Club of OV. Your Business is truly helping the community and part of the Town's 50th Anniversary celebration. We will let your customers know.

Oro Valley Rotary will provide to restaurants/businesses:

- \$250 (restaurants only) to cover the cost of the food paid after participation in the event.
- \$30 (restaurants/beverage providers only) Pima County Health Temporary Food Permit reimbursement.
- o A 10' x 10' tent
- o Two 6-foot tables one in back for prep and one in front for serving.
- o 11" x 17" sign with your restaurant/business name.
- Hand washing station required by the Health Dept.
- Three complementary tickets to TOVL for your booth staff.
- Advertising and promotion of the event.
- o Electricity to booth, if requested.

TOVL Restaurant Coupon Book
