HEIDI ANDERSON

TTF—The Trail Foundation

Heidi Anderson is the executive director of The Trail Foundation, the non-profit organization that works to protect, enhance, and connect the Ann and Roy Butler Hike-and-Bike Trail for the benefit of all.

The Butler Trail is the 10-mile lush, urban pathway in the heart of Austin that serves as the hub of the city's 130-mile trail system, circling Lady Bird Lake and passing skyscrapers, neighborhoods, sports fields and cultural attractions. With more than 2.6 million visits annually, the Trail is one of Austin's most popular recreational attractions, and has an economic impact of \$8.8 million annually.

As executive director of TTF, Heidi leads the Foundation's strategic vision and continued growth, including projects currently underway such as the Trail-wide ecological restoration, Holly Shores revitalization and enhancements to the East side of the Trail.

Her key duties include overseeing the administration, projects, programs and strategic plan of The Trail Foundation. Other responsibilities include fundraising, communications, marketing and community outreach.

During Heidi's tenure with The Trail Foundation, she has lead the efforts to establish criteria by which future projects are selected, announced the organization's ambitious 15 new projects in honor of its 15th anniversary in 2018, and created a Canopy Fund dedicated to financing the initial phases of each future project.

Heidi has also spearheaded the strategic modification of TTF's mission to include connectivity for the Butler Trail (in addition to protection and enhancement), unveiled TTF's completed \$2.5 million Trail Bridge at Congress Avenue project, was appointed by the City as a member and key stakeholder of the Zilker Working Group, has helped lead the Seaholm Intake Facility joint revitalization project with the Austin Parks Foundation and City of Austin's Parks and Recreation Department, and been a featured guest speaker at various esteemed summits including the Texas Trails and Active Transportation Conference and the American Institute of Architects Austin Summer Conference.

She and her family regularly enjoy the Trail for its urban access to nature and connectivity to community. Heidi's commitment to the Trail lies in the belief that this treasured asset, within Austin's core, is at the heart of what makes our city great and our people healthy.

Heidi came to TTF with 24 years of experience in nonprofits, most recently focused on protecting green space and building additional trails for Central Texans. Prior to taking the reins of TTF, she served as director of development for Austin-based Hill Country Conservancy. She is the third leader in The Trail Foundation's nearly 16-year history.

LAST WEEK'S PROGRAM RECAP (CONTINUED FROM PAGE 2)

After a few minutes of Fellowship time, **Tarby Bryant**, introduced our speaker, **Dr. David Altounian**, Interim Dean for the Bill Munday School of Business at St. Edward's University.

David is a native of Alexandria, LA and was involved with a number of businesses prior to getting involved in academia. He is currently the interim dean at the business school at St. Edward's but will become associate dean later this year. He has lived in Austin since 1994 and was an executive at Dell Computer for a number of years. Prior to that, he worked at Compaq Computers in Houston.

During his time with Dell, they asked him to be on the advisory board at St. Edward's and he has been involved at the university ever since. St. Edward's strives to be a great private university and is in the midst of a large capital campaign. They recently added new dorms and are continuously working to upgrade the physical footprint of the university as well as developing meaningful educational partnerships. They currently have partnerships on five continents.

St. Edward's truly believes in educating the heart and mind of students; faculty take this very seriously. They also believe that they don't have students for four years but have them for life! Current enrollment is about 4,500 students; 42% of students are Hispanic; 54% are minority; the student/teacher ratio is 13:1 which makes for a very effective teaching environment and helps retain students.

Faculty and students are from all over the world, and students come from all economic backgrounds. As a Holy Cross school, social justice is very important. St. Edward's is a Catholic university but has over 40 faiths represented on campus. Dr. Altounian was pleased to report that St. Edward's is the #1 producer of Fulbright Scholarships! He said he hoped they'd be the "Rice University of central Texas" but they need to build their endowment significantly first!

David teaches entrepreneurship and has made a concerted effort to integrate more into the Austin community in order to meet the needs of the region. St. Edward's is invested in the Capital Factory and has gone out into the community to partner with organizations in lieu of spending money on campus facilities. They are focused on building a curriculum to deliver value to their students and the community, and they want to be the easiest business school in central Texas to work with.

Isabel Medford, a student in the business school, spoke for a few minutes. She is in her third year and is a finance major. She noted that the course work has been extremely helpful, and she's had opportunities to meet with venture capitalists and start-up companies. She also has a seat at the Capital Factory and is very thankful for all of the opportunities provided at St. Edward's.

"There used to be major attendance issues at the Hilario Sanchez School in Nicaragua. Students weren't attending school to work in their families' businesses in order to eat. Rise Against Hunger partnered with the North Country Mission of Hope to ensure our meals were administered at school to encourage attendance.

Things are changing for those kids in Nicaragua. Attendance rates are nearly 100% and academic performance has increased. These students are learning reading and writing, along with essential skills that will secure their place within society. From surviving to thriving, each student has a chance to be their best selves — thanks to your support. One warm meal a day is leading to literacy."

ST. DAVID'S PARKING GARAGE MESSAGE/INSTRUCTIONS

A message from President Julie about parking: Premier Parking/St. David's garage manager, Angel, will provide 50 parking spaces in the garage every Tuesday for our use. Once those spaces are taken and there are no other parking spaces members should either try to find parking on the surface lot on the church property, which may or may not have spaces available, <u>**OR**</u>...

Drive over to Premier's Trinity surface lot which is on Trinity and 8th, catty-corner to St. David's parking garage. (It's the corner lot that is very steep.) You may also start there, if you'd like. If you park there, go to the kiosk on that lot and punch in the numbers, **1905**. You will <u>not</u> be charged for parking in either the small, surface lot on the church campus nor the Trinity surface parking lot.

Please continue to use your laminated barcode to enter the parking garage and <u>don't punch the</u> <u>button for a paper ticket</u>. Our code is read by the parking system and an accurate count of members will be reported. If you have a guest coming, they *will* take a paper ticket and then they will need to ask the Hospitality Team, when they check in, for a one-time use QR code to exit the garage. If any of your guests park in Premier's Trinity surface lot then they will need to punch in the numbers **1905** at the kiosk, too.

I am deeply sorry for the frustration that many of you have felt, and we all continue to feel, due to the lack of sufficient parking. I'm open to any suggestions for alternative parking arrangements and hope we can focus on our weekly fellowship and continue to positively change our community and the world.

AUSTIN CENTRE—OVERFLOW PARKING REMINDER


As a reminder — we still have an agreement with Austin Centre (the building right across San Jacinto from the Church...think the Omni, but not — *see map image*)

where they will try to provide overflow parking in their garage on (most) Tuesdays during our weekly lunches!

This garage is MUCH more expensive for us than when you park in St. David's garage, however, since they charge us in 20 minute increments (not a flat rate). <u>So please try to</u> park at St. David's first.

If you park in the Austin Centre garage, you MUST request a validation ticket from one of the Hospitality members when you check in at the meeting! Please note that this is ONLY AVAILABLE for a few hours each Tuesday (you can't park your car there all day for free nor can you park there for free on any other day of the week).

To enter the Austin Centre parking garage, come down 7th Street and turn left onto Brazos. The parking garage entrance is on the right.



If you park there, don't forget to ask the Hospitality Team for a complimentary validation voucher/ticket! YOUR LAMINATED BARCODES WON'T WORK IN THIS GARAGE!
