This Week's Program

RICK TIMMINS

Opportunity Zones and Residential/Multi-Family Development in Austin

Rick is a resident of Austin, Texas and is heavily involved in the Austin start-up community. He is the former Board Chairman (six years) and member of the Central Texas Angel Network (CTAN), the most active angel network in the country. He has personally invested in 44 start-up companies since 2009 and has assisted many

entrepreneurs with insight and recommendations through mentoring and formal participation on Boards, accelerators and incubators. Rick is also one of the two partners in Mid-City Development, a development and construction business in Austin which specializes in the development of mixed use apartment/condo/townhome communities in Austin neighborhoods. Mid-City currently has nine projects in various stages of development.

He brings with him 35 years of experience in financial management and strategic guidance from two Fortune 50 technology companies. Rick served as Vice President, Corporate Controller and Assistant CFO of finance at networking technology leader Cisco Systems from 1995 to 2007. There he was instrumental in developing and implementing an e-culture of financial reporting across all of Cisco's worldwide operations. When he arrived in 1995 it took Cisco 21 days to close its monthly reporting books. Under his leadership that task was reduced to less than 1 day worldwide.

Prior to Cisco, Rick served as Vice President of finance for Motorola for 23 years. He had worldwide financial responsibility for the MOS Semiconductor Group for several years. He also was also the CFO for Motorola Japan living in Tokyo for 6 years and assisted in helping to develop Motorola's cellular and semiconductor operations in Japan, which experienced high growth from \$200 million to over \$2.5 billion. *Story continues on page 3*.

ST. DAVID'S PARKING GARAGE MESSAGE/INSTRUCTIONS

A message from President Julie about parking: Premier Parking/St. David's garage manager, Angel, will provide 50 parking spaces in the garage every Tuesday for our use. Once those spaces are taken and there are no other parking spaces members should either try to find parking on the surface lot on the church property, which may or may not have spaces available, **OR**...

Drive over to Premier's Trinity surface lot which is on Trinity and 8th, catty-corner to St. David's parking garage. (It's the corner lot that is very steep.) You may also start there, if you'd like. If you park there, go to the kiosk on that lot and punch in the numbers, **1905**. You will <u>not</u> be charged for parking in either the small, surface lot on the church campus nor the Trinity surface parking lot.

Please continue to use your laminated barcode to enter the parking garage and <u>don't punch the button for a paper ticket</u>. Our code is read by the parking system and an accurate count of members will be reported. If you have a guest coming, they *will* take a paper ticket and then they will need to ask the Hospitality Team, when they check in, for a one-time use QR code to exit the garage. If any of your guests park in Premier's Trinity surface lot then they will need to punch in the numbers **1905** at the kiosk, too.

I am deeply sorry for the frustration that many of you have felt, and we all continue to feel, due to the lack of sufficient parking. I'm open to any suggestions for alternative parking arrangements and hope we can focus on our weekly fellowship and continue to positively change our community and the world.

AUSTIN CENTRE—OVERFLOW PARKING REMINDER

As a reminder — we still have an agreement with Austin Centre (the building right across San Jacinto from

the Church...think the Omni, but not - see map image) where they will try to provide overflow parking in their garage on (most) Tuesdays during our weekly lunches!

This garage is MUCH more expensive for us than when you park in St. David's garage, however, since they charge us in 20 minute increments (not a flat rate). So please try to park at St. David's first.

If you park in the Austin Centre garage, you MUST request a validation ticket from one of the Hospitality members when you check in at the meeting! Please note that this is ONLY AVAILABLE for a few hours each Tuesday (you can't park your car there all day for free nor can you park there for free on any other day of the week).

To enter the Austin Centre parking garage, come down 7^{th} Street and turn left onto Brazos. The parking garage entrance is on the right.



If you park there, don't forget to ask the Hospitality Team for a complimentary validation voucher/ticket! YOUR LAMINATED BARCODES WON'T WORK IN THIS GARAGE!
