RECAP FROM LAST WEEK'S PROGRAM

Andres Alcantar — COO, Texas Association of Business (TAB) April 30, 2019 Reported by Andy Swanson

President Julie called the meeting to order and led our saying of our *Vision Statement*. **Grant Sparks** led the pledges and **Leslie Bagby** gave our invocation of the day. **Gary Gerstenhaber** led us in saying the *Four Way Test*. **Alison Michels** greeted each member and guest as they arrived and **Caroline Valentine** introduced our guests and visitors.

Past President Barry Curlee announced that the "Brainstorming Session #3" will be held after our lunch meeting today. Everyone is welcome to attend to discuss fundraising ideas!

Mary Reynolds followed him and reported she needs volunteers to help pack bags of fresh fruit and vegetables during June and July to give to students at Hart Elementary. Please let her know if you can help.

Past President John Braziel provided an outstanding update regarding one of our past scholarship recipients – **David Padilla-Arenivar** – during the *Membership Minute*. David attended Del Valle High and was one of the top students in his graduating class. In addition to the scholarship he received from us, he also received a Gates Millennium Scholarship to cover the balance of his college expenses, including tuition and books. He was set to attend St. Edwards University to study graphic design when his mother became ill and his father left their family. He contacted John who presented a request to our Austin Rotary Club Foundation asking that the scholarship funds be used to provide money for food and housing to David's family for three months. Without this generosity, he and his mother would have been homeless. David has since excelled in college, maintaining a 3.98 GPA majoring in computer science with a minor in graphic design. He will graduate and attend grad school at UT Austin. Congrats to David!

Tillery Castillo reminded us about our Spring Social/Membership event that will be held at **President Julia and Harold Benkoski's** home on Saturday, May 18 from 4-6pm. Please plan to attend, and if you know someone who is interested in Rotary invite them, too! This will be a casual and family-friendly event.

President Julie announced that if you are interested in becoming an advertiser in our newsletter, please contact Jenn! Cost is \$250 for six months. Then we enjoyed a solid ten minutes of fellowship!

Tarby Bryant introduced our speaker, **Andres Alcantar**, the COO of the Texas Association of Business (TAB). Andres has been COO at TAB since July 2018. He grew up in West Texas and attended college at Texas Tech where he received a bachelor and master's degree in public administration.

He reported that, with a state unemployment rate of 3.8%, it is a great time to be in Texas! Texas has now had 107 months in a row of job growth and every sector of our economy has added jobs. Last year, Texas led the country with \$315 billion in exports, which is up 20% from 2017! Times are good but pressure from global competition is fierce, and we must be vigilant and strategic in order to continue on this path.

TAB is focused on growing the economy of Texas. Founded in 1922, they are the "state chamber of commerce" and work on behalf of all businesses in Texas. Texas is currently ranked as the top state to do business, and we are working to stay at the top.

Andres said that Texas continues to lead the country in corporate relocations, and due to all of the growth, we are facing many challenges. With state population growth of 18% since 2010, we must figure out ways to address issues caused by this rapid growth. The state Legislature is facing a number of challenges in the current session, but with the growth in tax receipts and use of the rainy day fund the state is in a good position to find solutions.

TAB works with state and local governments to address priorities including education, economic development, infrastructure and property tax reform. They are also focused on federal issues regarding trade and NAFTA 2.0 and need to address issues regarding tariffs and the need to get Texas' fair share of the gas tax receipts from the federal government (Texas is the only state that is a net donor in the country).

TAB advocates and provides a number of benefits for its members. They are currently rolling out a health plan for their association members for companies with two to fifty employees. Please contact Andres if you would like information on becoming a member of TAB.

RECAP FROM PROGRAM ON APRIL 23RD

Randy Clarke — CEO, Capital Metro April 23, 2019 Reported by Andy Swanson

President Julie called the meeting to order. **Jackie Sinex** led the pledges and **Michele Heyman** gave our invocation of the day. **Jim Bryce** led us in saying the *Four Way Test*. **Maxie DeBlanc** greeted each member and guest as they arrived and **Russell Gana** introduced our guests and visitors.

President Julia introduced our newest member – **Rupal Chaudhari** (sponsored by **Mark Johnson**). Welcome, Rupal!

Paul Harris Fellowship Awards were presented to **Tom Anderson** (PHF Initial), **Vlad Bahrencu** (PHF +1) and **Rich Fikani** (PHF +2). Please congratulate them all!

President Julie noted that everyone is invited to a wine tasting at **Peter Pfeiffer's** home on River Road in Tarrytown on Friday, April 26. Please put this on your calendar!

Mark Kapner provided the *Membership Minute*. He has been a Rotarian for 18 years. He was brought up on the Hebrew tradition of "healing the world" and this led him to getting involved with Rotary. The moon landing in 1969 sparked his interest in engineering; and he studied engineering in college and then worked in the energy industry. He recently formed a company called Kapner Solar and is looking for investors.

Tillery Castillo announced our Spring Social Event that will be held at **President Julia and Harold Benkoski's** home on Saturday, May 18 from 4-6pm. Please plan to attend and bring your family or a friend! This will be a casual and family friendly event.

Andy Swanson gave an announcement regarding an upcoming service project with Habitat for Humanity. He is confirming the date for our group and will let everyone know once it has been set.

Ann Graham led today's *Thank Goodness Basket*, and we heard from a number of thankful Rotarians including: Tom Locke, Sylvia Holmes, Mark Johnson, Michele Heyman and Sherry Workman.

Tarby Bryant introduced our speaker, **Randy Clarke**, who is the CEO of Capital Metro. Randy has been CEO at Cap Metro since March 2018. He is originally from a small town in Canada. Thus, he is still learning about Austin, but he said he truly feels that Austin is the friendliest place he has ever been! He conducted a quick poll of the audience and found that a number of our members had never used Cap Metro or any kind of public transportation. He spoke about the value of transit and the need for continuing to improve our transit system as our population continues to grow at a rapid pace.

He stated that, like our *Four Way Test*, transit needs to be fair and it needs to be beneficial to everyone – it must treat everyone equally. Cap Metro has improved and added new bus routes. By taking more people off road and putting them on mass transit – this improves driving conditions for others.

Over the next 18 months they will be focusing on community engagement — looking for feedback from the community about wants and needs. Randy feels that Cap Metro must do more to contribute to the community, but he thinks that communication with the public is more challenging than ever. With proper planning, we can manage our growth, but we'll need to build infrastructure to support all of the new large developments across the region (i.e. Plaza Saltillo, Domain, McKalla Place). We must think regionally in order to build a cohesive plan for transit.

Randy discussed several of Cap Metro's rail lines, including two new ones: The Blue Line would run from the airport along Riverside Drive to the convention center. The Orange Line would run north/south through Austin. The existing Red Line needs to turn into the "workhorse" for commuters. Now have electric powered buses in service and are constructing an electric charging facility in north Austin near Burnet Road and US 183.

The Cap Re Map project has recently redesigned the bus network to better fit user needs. Since June 2018, ridership is up every month. Will be opening a new park-and-ride station at Westgate in South Austin. Currently working on Project Connect — a multiyear planning project to improve Cap Metro and build for the future (https://capmetro.org/ProjectConnect/). They are ready to try to help deliver solutions as the Austin area grows from 2M people to 4M people over the next 20 years!

Next week we'll hear from Jeff Moseley – CEO, Texas Association of Business. We then recognized and thanked **Corey Wilson (Kidd Rooding)** and **David Doran (Texas Systems Group)** for sponsoring the newsletter! 








ST. DAVID'S PARKING GARAGE MESSAGE/INSTRUCTIONS



Premier Parking/St. David's garage manager, Angel, will provide 50 parking spaces in St. David's garage every Tuesday for our use, although they may or may not be roped off for us. Once those spaces are taken and there are no other parking spaces members should either try to find parking on the surface lot on the church property, if there are any spaces available, OR...

Drive over to Premier's Trinity surface lot which is on Trinity and 8th, catty-corner to St. David's parking garage. (It's the corner lot that is steeply slanted — see map image to the left.) You may also start there, if you'd like. If you park in this surface lot, go to the kiosk (on the lot) and punch in the numbers, 1905. You will not be charged for parking in either the small, surface lot on the church campus nor this

Trinity surface parking lot.

Please continue to use your laminated barcode to enter the parking garage and don't punch the button for a paper ticket. Our code is read by the parking system and an accurate count of members will be reported. If you have a guest coming, they will take a paper ticket and then they will need to ask the Hospitality Team, when they check in, for a one-time use QR code to exit the garage. If any of your guests park in Premier's Trinity surface lot then they will need to punch in the numbers **1905** at the kiosk, too.

Club leaders continue to try to identify alternative parking solutions for us and welcome any suggestions from members.

AUSTIN CENTRE—OVERFLOW PARKING REMINDER

Don't forget that we still have an agreement with Austin Centre (the building right across San Jacinto from the Church...think the Omni, but not - see map image to the bottom right) where they will try to provide overflow parking in their garage on (most) Tuesdays during our weekly lunches!

This garage is MUCH more expensive for us than when you park in St. David's garage (or in the Trinity


Surface Lot), however, since they charge us in 20 minute

increments (not a flat rate).

If you park in the Austin Centre garage, you MUST request a validation ticket from one of the Hospitality members when you check in at the meeting! Please note that this is ONLY AVAILABLE from 11:00-2:00 each Tuesday and is unavailable on any other day of the week.

To enter the Austin Centre parking garage, come down 7th Street and turn left onto Brazos. parking garage entrance is on the right.

If you park there, don't forget to ask the Hospitality Team for a complimentary validation voucher/ticket! YOUR LAMINATED BARCODES WON'T WORK IN THIS GARAGE!
