## 204 Infrastructure Upgrades

Indian Prairie School District 204 Superintendent Adrian
Talley stopped by to flesh out the District's bond referendum appearing on the November 5 ballot. The proposal reads: Shall the Board of Education of Indian Prairie Community School Unit School Number 204 ...alter, repair and equip existing school buildings, including constructing security improvements, including installing secure entryways,



access controls and intrusion detection, replacing roofing, mechanical, plumbing, and HVAC systems, updating classrooms, science labs and libraries/media centers, enhancing energy efficiency, and issue bonds of said School District (in the amount of \$420-million) for the purpose of paying the costs thereof. The bond does not trigger a tax rate increase. Talley said the District is faced with numerous upgrades that have emerged simultaneously.

"(District) 204 spends less per student than other districts. The state determines what your funding can afford based on the size of your District and the funding you get from property taxes. The state says we're 84 percent adequately funded; that means we can only afford 84 percent of what we should be able to afford (including) teachers, administrators, and other staff." He noted that School District 203 is at 119 percent funding adequacy. "District 203 this year spent \$40 million on construction needs and they just took that money out of reserves."

Talley added that "Illinois does not give capital money to school districts, so all the funding from taxpayers goes into our operating budget. Anything we want for capital must come from that. We should spend 8-10 million dollars a year on capital work; take that amount out of our operating budget (and) we would have to cut other things, beginning with personnel. In this case, that would eliminate about 80 positions."

## No Judgement Zone

Virtually all Naperville residents know they have an outstanding public library offering something for everyone, including books, music, movies, video and board games, research assistance, story sessions for children, and computer work stations. Public support of libraries is especially important at a time of increasing pressure to censor "politically incorrect" materials. Naperville Public Library (NPL) Executive Director **Dave Della Terza** was unequivocal when he spoke to our Club:

"Libraries take intellectual freedom very seriously...that means we want to have a varied collection and that we don't censor things based on points of view or someone not liking something in our collection," Della Terza said. "We have controversial, unpopular, unorthodox materials. Customers can choose not to check out titles for themselves or their children, but they can't restrict the freedom of others...or remove things from their collections because it offends someone. That's in the American Library Association Bill of Rights."

The NPL has 227 staff members at three locations: 2035 South Naper Blvd.; 3015 Cedar Glade Drive (95<sup>th</sup> Street Library); 200 West Jefferson Avenue (Nichols Library).

The Sunrise Board approved a motion to use \$1,000 of our Greater Good Fund to support hurricane relief efforts sponsored by Rotary and the Greater Good Charities. #### 2024 First Lego League Tournament

Our Vocational and Youth Committees are collaborating to sponsor the District 203/Naperville Education Foundation (NEF) First Lego League (FLL) Tournament. The event is scheduled for November 23<sup>rd</sup>

at Kennedy Junior High School. NEF Executive Director **Wendy Goettsch** says the theme of this year's tournament is *Submerged*. "Teams will use their STEM and collaboration skills to explore life beneath the surface of the ocean. Along the way, we'll uncover the potential in each of us to strengthen our community and innovate for a better world with healthy oceans." The NEF supports STEM education outside the school day for over 500 students across all 14 elementary and five junior high

schools through the (FLL) program. For the first time, this year's tournament will include Junior High students. Forty-five teams will participate.
