

Rotary International District #6490 Rotary Club of the Year Award Criteria

(Large Clubs 50+ members and Small Clubs 49 members and less)

Recognizes the Club that has performed in the highest traditions of Rotary during the previous year. The Outstanding Rotary Club of the Year will demonstrate high achievement as an effective Rotary club.

Award

The District 6490 Outstanding Rotary Club of the Year Award (Large or Small Club) is a large cloth banner that the Club may display for one (1) year. The banner typically has the Rotary wheel and the words "District 6490 Rotary Club of the Year," the name of the club, the name of the Club President and year of presentation. The award will be presented at the annual District 6490 Conference (Oct. 4-5, 2024).

NOMINATIONS

Each member may nominate one (1) Rotary club.

SELECTION

The District Governor and members of the District Awards Committee members will be the Selection Committee.

SELECTION CRITERIA

Main Criteria

1. All Clubs nominated should qualify for the Rotary Citation awards.

- 2. All Clubs nominated should show a net increase in Club membership (excluding Honorary members) between July 1 thru June 30 of the current Rotary year.
- 3. Membership increase may include those who have been approved for membership by the Club before the year ends, but may not have been formally inducted or added to the RI database.

Optional Criteria

The following may be considered:

Membership Development:

- Specific membership development programs undertaken by the Club in the current Rotary year
- New member orientation, mentoring and member education initiatives developed by the Club
- Sponsorship of a new Rotary, Interact, Rotaract or Satellite Club
- Public Relations programs undertaken by the Club in the current Rotary year

Service Projects:

- Current local service project(s)
- Current World Community service project(s)
- Level of hands on Club involvement in service projects rather than the dollar value should be considered the primary factor
- Sponsorship of Youth Exchange students
- Active involvement with an Interact and/or Rotaract Club(s)
- Sponsorship of candidates to RYLA and other Rotary sponsored youth programs

The Rotary Foundation:

- The Club's per-capita contribution to The Rotary Foundation Annual Program fund
- The number of new Benefactors, Bequest Society, Paul Harris Society and Major Donors during the current Rotary year
- Rotary Foundation program presentations at regular Club meetings

• Applications for The Rotary Foundation grants

Service Beyond the Club:

- Club members service on District, Zone, or RI committees and task forces
- Club attendance at District training seminars and other District events
- Club registrations for the upcoming RI International Convention and/or the District
