Sales Tax: The State of Florida requires sales tax to be paid on all goods sold at this festival. Vendors are responsible for paying sales tax directly to the State of Florida.

Beverage Sales: You may sell **non-alcoholic** beverages. Please note that beverage sales have traditionally been a key fundraising activity for our club, and we appreciate your understanding.

Vehicles: NO Golf carts and other motorized vehicles are prohibited on the event premises during the event, except for those approved and operated by Rotary Club representatives or the City of Homestead. Exceptions include refrigerated trucks, subject to approval, which may be parked in a designated area behind the food vendor booths. All other vendor parking is located outside the event gates in a designated parking area.

Miscellaneous Rules:

- No pets are allowed.
- No refunds will be issued.
- No offensive products or displays are allowed. The Rotary Club of Homestead Charitable Foundation, Inc. reserves the right to determine what constitutes "offensive."

Liability: Sponsors, including the Rotary Club of Homestead Charitable Foundation, the Rotary Club of Homestead, and the City of Homestead, are not responsible for any loss, injury, or damage sustained by a vendor, exhibitor, its employees, or guests. The exhibitor agrees to indemnify and hold harmless all sponsors. Vendors causing damage to the premises or property will be liable for the cost of repairs and any related expenses.

Each food vendor is permitted ONLY ONE vehicle per 12' space, which may include a car, truck, or storage/equipment trailer.

Limited general lighting will be provided. If you need lighting for your booth, you must provide it.

Water will be provided. **All food vendors are required to supply and maintain a hand-washing station in their booth.**

All workers in food vendor spaces must wear sanitary gloves.

A food service permit is not required, but all food vendors must comply with Florida Department of Business Regulation health rules.
