The <u>4-Way</u> Test

From the earliest days of Rotary, Rotarians have been concerned with promoting high ethical standards in their professional and everyday lives. One of the world's most widely printed and quoted statements of business ethics is the 4-Way Test, which was created in 1932 by Rotarian Herbert J. Taylor (who later served as Rotary International's president) when he was asked to take charge of a company that was facing bankruptcy. This 24-word test for employees to use in making decisions in their business and professional lives became the guide for sales, production, advertising, and all relations with suppliers and customers. The survival of the company is credited to this simple philosophy. Adopted by Rotary in 1943, the 4-Way Test has been translated into more than a hundred languages and published in thousands of ways. It asks the following four questions:

Of the things we think, say or do:

- 1. Is it the TRUTH?
- 2. Is it FAIR to all concerned?
- 3. Will it build GOODWILL and BETTER FRIENDSHIPS?
- 4. Will it be BENEFICIAL to all concerned?

The Purpose and Goals of the Contest

The purpose of the 4-Way Test Speech Contest is to foster the principles of ethics in everyday life as well as in business. The Contest is designed to introduce high school students to Rotary by creating interest through a competitive speech contest, sponsored by their local Rotary club.

The specific goals of the Contest are:

- To acquaint a large number of youth with Rotary, and specifically, the tenets of the 4-Way Test.
- To demonstrate and enhance Rotarians' commitment to youth.
- To heighten awareness of Rotary among students, parents, school officials, and the community at large.
- To recognize, encourage and reward hard work and accomplishment in our youth.
- To provide an opportunity for Rotarians to participate in a Community/Vocational Service program which focuses on the 4-Way Test as our standard of behavior.





General Information for Clubs

There are three levels of competition: <u>Club</u>, <u>Regional</u> and <u>District</u>. Each club will conduct their local club level contests during by the end of February 2025. Club contests MUST be completed by **Feb. 28, 2025** and submit the contestant winner's information to the District 7360 Contest Chair using the <u>Student Entry</u> and <u>Biography forms</u> included with this manual by March 1, 2025.

The District Contest Chair will conduct Two or Four Regional Contests (depending on the total number of clubs participating) during the month of March 2025. The District 4-Way Test Speech Contest Committee will be responsible for organizing these contests. Specific dates and locations for these contests will be determined based on clubs entering the contest.

The District level competition will be held after the completion of the Regional Contests. The contest will be held at the spring district conference being held at the Omni Bedford Springs Hotel 2138 Business 220, Bedford, Pennsylvania, 15522. The District 4-Way Test Speech Contest committee will conduct that contest. The winning speaker from each of the Regional contests will compete in the District level competition. If only 2 regional events are held, the 1st runner up will also be eligible to participate in the district contest. If the winner, or 1t runner up is unable to compete in the District level competition, the 2nd runner up of the Regional contest will be eligible to compete.

STUDENT ELEDGABILITY: <u>Public, private and home-schooled school students</u> in grades 9 through <u>12</u> are eligible to enter the contest. The student does NOT need to be a member of Interact. No student may be a contestant in more than one Rotary Club speech contest in any one year. A club may sponsor a speech contest in more than one high school but may send only one representative to the Regional contest. **Previous winners of the District Level speech competition (District Champion) are ineligible to compete in subsequent years, but other previous competitors may compete again.**

Clubs are encouraged to advertise their club contest and results. So to keep the contestants anonymous from future contests and judges, **please refrain from naming contestants names or schools until after the competition events have been concluded.**

Levels of Competition and Awards

1. Local or Club

All Rotary Club level 4-Way Test Speech Contests must be completed by February 28, 2025. It is easier if a maximum of six (6) speakers compete in the Club Contest. At the discretion of the club, participants can receive a 4-Way Test plaque, participation certificates, and/or cash awards. If your club elects to award cash prizes, awards of \$100, \$50 and \$25 are suggested for the first three places. The winners of each club competition will advance to the regional competitions.

Multiple clubs from an area can join together to hold the local or club level contest, share expenses and work together to recruit students.

2. Regional

The regional competitions will be held during May 2025. Specific dates and locations are to be determined. All participants will receive recognition certificates. The three top winners will receive at least \$300, \$200 and \$100 cash awards, respectively. The First-Place winner of each Regional Contest will advance to the District Finals.

NOTE: The District 4-Way Test Speech Contest committee reserves the right to change dates and locations of the regional contests and club assignments to regional contests depending on the clubs that sign up for the competition.

Transportation, meals, lodging and other incidental costs to participate in the regional contest is the responsibility of the club or participant.

3. District Final

The Regional contest winners (and possible 1st runners up) will compete at the District Final on March 29th 2025. The contest will be held in Bedford PA. The date/time coincides with the District Conference planned for the same day. In recognition of their accomplishments and to further their education, the District Champion will receive at least \$2,000 cash award, the first runner up will receive \$1,000 and the other two runners-up will each receive a \$500 cash awards.





Your Club Contest: What You Need To Do

- 1. Notify the District Chairperson (Art Leach: artleach77@gmail.com) by email that your club intends to participate as soon as you decide. Return the Club Entry Form, with payment by January 31, 2025. Any questions contact the District Chair.
- 2. Have your committee review the contents of this Manual. Make copies of information that you want to distribute. Note: Individual forms are available on DACdb as well as in this manual.
- 3. Contact the High School, charter or other schools and explain the contest. Find a cooperating teacher and make contact with them. Volunteer to go to the school and teach the lesson that explains all about Rotary, the 4-Way Test and the Speech Contest, why we have it, what the speeches should be about, how they are judged, and what the prize money will be. (See the sample Lesson Plan on pages 11 -12). Follow all school and Rotary youth protection guideline regarding child safety.
- 4. It is recommended that there be no more than six (6) contestants in a club contest but for larger mulit-club events, more can be managed. If necessary, Rotarians from your club should go to the schools to conduct semi-finals. If there is only one participating school in your area, the contest and judging can be held at a club meeting as the program. If more than one school from your area is competing, have the winners from each school present their speeches as a competition at a regular meeting.
- 5. For the club meeting when speeches are given, invite the parents, principal, and cooperating teacher(s) in addition to the speakers. The club should pay for any additional meals. The award of cash prizes, 4-Way Test plaques, pens, etc. is at the discretion of the club. If cash awards are to be given, it is recommended that awards of \$100, \$50 and \$25 be given to the 1st, 2nd and 3rd place winners, respectively.
- 6. Use the enclosed judging sheet to determine winners. This will be the scoring sheet used at the Regional and District levels. Be sure the participants have seen and use the form when developing their speeches.
- 7. Have some "filler time" available during judging. (See Sample Club Contest Agenda).
- 8. Prepare press releases, take pictures if possible, so to acknowledge your contestants and provide your club with additional Public Relations (after the district level competition is completed).
- 9. Should your contestant win at the Club level, plan to have a Rotarian chaperone your participant and participant parent at the Regional competition. Please plan ahead!





School Visit / Sample Lesson Plan

The purpose of a school visit is to engage students and the cooperating teacher in discussion, so they have a clear understanding of the 4-Way Test Speech Contest.

Prior to visiting the class, review the Rotary Youth Protection Guideline resource from Rotary International.

Introduce yourself to the class as a member of your Rotary Club, which is part of District 7360.

Ask if anyone knows anything about Rotary. You will usually get blank stares, rolled eyes, laughter, or possibly an answer. Ask if they ever noticed the Rotary emblem on one of the street signs. Show them your pin.

Ask them if they have any idea why you are addressing them and what's in it for them. Ask them if any of them plan to either seek employment or go on to college after graduating. Explain that there is value in both ethics and public speaking. Explain that on a college application, or a resume, participation in the 4-Way Test Speech Contest is noticeable and can open doors for them.

Ask to have them let you back up just a minute and explain about Rotary in general and your club in particular, and how they can benefit. Explain that Rotary is an international organization with over 1.2 million members in over 220 countries. Rotary has five avenues of service: Club, Vocational, Community, International and New Generations. The Speech Contest falls under Vocational Service because it is designed to offer a competitive speech contest that encourages ethical thinking and enhances self-confidence through public speaking. Explain that your Club is one of 66 in District 7360, which runs from the New York State border through central Pennsylvania, and into Western Maryland and Eastern West Virginia.

Say that this is a real competition.

Ask if anyone in the room could use over \$2,000 in prize money. This will usually stimulate some positive reaction. Mention the Youth Exchange, and RYLA (Rotary Youth Leadership Awards) programs.

Get back to the speech contest and explain what it is and how it works.

If you have the ability, play a You-Tube video of a speech being given.

Explain that it is a five-to-seven-minute ethics-based speech that uses the Rotary 4-Way Test of the things we think, say, or do, to help solve an ethical or moral issue from their own experience.

Tell them what the 4-Way Test is.





School Visit / Sample Lesson Plan (cont'd)

Ask if anyone can think of a situation to discuss. If they can't, give them a little help with an example, such as, smoking, distracted driving, volunteering, etc.

Make this part fun by asking challenging questions. If they come up with an idea or statement, drill down by asking them questions that make them think and expand their views.

How can they structure a speech around this topic? Try these examples and do it by asking questions that stimulate thought. (Questions that begin with How does . . .

My friends and I want to smoke but my parents don't want me to. Or, some kids don't want to be friends with me because I smoke, but they should accept me for who I am and not for just one thing that I do.

Build a discussion around this: is the issue about smoking, health, peer pressure, rebellion, or enjoyment, etc. What is the truth about smoking and health, finances, peer pressure, independence, relationships? Is smoking fair to the smoker and others, etc.? How does it build good will and better friendships? How and why will it be beneficial and to whom? Use the discussion to help them move to a conclusion. Maybe their conclusion will be affirmed, or maybe it will change their mind if THEY decide that THEY don't want to smoke.

Maybe someone has a family member who has to go to a nursing home and they feel guilty about that decision. Sure, reasons for going to a nursing home are real and very true, but how do you deal with feelings and the finances involved when making those decisions.

Best picks for subject matter are something the students bring up. Be creative about how to structure a speech around topics. Point out that good speeches often have the simple, obvious answer vs. deeper and more complex issues.

The idea is to have them understand that they can come up with the idea for the speech and that they can make it compelling. Most important is that they have gone through a process for how to make a better decision.

Point out that the test can be used to prove or disprove either a positive or a negative issue. However, emphasize that the scoring will give more weight to a positive application of the 4-Way Test.

Have the cooperating teacher write on the board, and have the students write in their notebooks the following web information: www.district7360.org. Tell them to visit the link on the District website homepage to the District 4-Way Test Speech Contest. Contest information and registration forms can be found in the on-line manual and as separate items.

Let the cooperating teacher and the students know that you are available to help them with any questions.





Checklist for Club Speech Contest Chair

September through January

- □ Let the District Contest Chair know that you will participate.
- □ Send in the Club Entry Form and Entry Fee by January 31, 2025
- Schedule Club Contest during January/February 2025; must be completed by February 28, 2025
- Determine Club Prizes for Club Contest.
- □ Talk with speech/drama/other teachers at each school in Club area.
- □ Give posters to each school.
- □ Explain 4-Way Test speech contest to teachers.
- □ Teach one (or more) classes about Rotary and the 4-Way Test (this activity should be coordinated with the school administration and teacher(s) See a Sample Lesson Plan on Page 11-12).
- □ Give copies of the Contest rules (Page 4) and Student Entry forms (Page 19) to each teacher or students if you teach classes about Rotary.

January

- □ Hold school runoff contest (if necessary).
- Get participants from each school (6 is the usual limit for a club level contest).
- □ Order Club trophies, plaques, certificates, etc.
- Put Club Contest date in Club Bulletin.
- Get 4 Judges 3 Judges and 1 backup.
- □ Get a Timekeeper and a Teller (to tabulate judges Scoring Sheets).
- □ Make food arrangements as needed.
- Arrange newspaper coverage.
- □ Confirm participants attendance and if parents plan to attend.





Checklist for Club Speech Contest Chair (cont'd)

January/February Club Contest

One Week Before Contest:

- □ Pick up trophies.
- □ Arrange for prize money.
- □ Give Judges and Timekeepers instruction sheets.
- □ Arrange for calculators for Judges (if needed).

Day Of Contest:

- □ Remind Judges, Timekeeper and Teller (Maybe this should be done the day before).
- □ Remind Newspaper of contest (Maybe this should be done the day before).
- □ Arrange seating for contestants and guests.
- □ Greet contestants.
- □ Make sure timekeeper has a stopwatch, or stopwatch app for phone or tablet.
- □ Bring calculators for Tabulators.
- □ Record the first runner-up in case the winner is unable to compete at the next level of competition.

After Contest:

- Make arrangements for the Club winner to attend the Regional contest, the date & location for your region will be sent to club contact but can be confirmed by contacting the District Chairperson.
- □ <u>IMPORTANT:</u> By February 28, 2025 send the club winner's Signed Entry Form (Page 19) & Speaker Biography Form (Page 20) to:

Sample Club Contest Agenda

- 1. Once contestants have arrived, have them draw a number to determine their speaking order.
- 2. The Master of Ceremonies of the contest may make the following announcements at the beginning, but you may wish to make them between the speeches, when the judges will need a moment or two to finish marking their score sheets:
 - Each contestant has chosen the topic of his or her speech. The purpose of the speech is to address an ethical issue using the principles of Rotary's 4-Way Test:

Of the things we think, say or do:

- 1. Is it the TRUTH?
- 2. Is it FAIR to all concerned?
- 3. Will it build GOODWILL and BETTER FRIENDSHIPS?
- 4. Will it be BENEFICIAL to all concerned?
- Speeches must be at least 5 minutes but no more than 7 minutes in length. Penalty points are assessed if a speech if too long or too short.
- Our winner today will advance to the Regional Contest in April. Runners-up at the Regional contest will receive \$200 and \$100 cash awards, respectively and the Regional contest winner will receive a \$300 cash award and advance to the District Finals.
- Winners of the four Regional Contests will advance to the District Finals. The District contest winner will receive a \$2,000 cash award, the first runner up will receive \$1,000 and the other two contestants will each receive \$500 cash awards.
- Ask for quiet for all speakers. No one should enter or exit during a speech. Food servers should refrain from serving or bussing during a speech
- <u>Ask people to turn off cell phones</u>
- 3. The Master of Ceremonies should explain that each speaker will be introduced by <u>NUMBER</u> <u>ONLY</u> with no mention of names or school affiliations until after all contestants have given their speeches. Also explain that there should be <u>no applause</u> between speakers and that there will be silence between speakers, so that the audience does not influence judges and the judges have an opportunity to rate the speakers (posting a sign on the podium is recommended). Do not point out the judges or timekeeper before the contest, although it will probably be obvious who they are.
- 4. After the last contestant has spoken, invite the judges and the teller to leave the room to tally their points and rank the speakers.





Sample Club Contest Agenda (cont'd)

- 5. Have the audience applaud for all of the speakers at the conclusion of all speeches only. Invite each speaker up by number and have them give their name, grade, school, extracurricular activities, and plans for the future, and anything else you want to include. Note: you may want to do this after the judge's return, as judges usually want to hear about the students as well.
- 6. When the judges return with their rankings, introduce them, the timekeeper and the teller. Then announce the second runner-up, first runner-up, and winner. (The first runner-up speaker will represent the club in the event the winner cannot participate in the Regional contest). Present awards/ plaques/certificates. Explain that the winner will now go on to represent the club at the Regional contest.
- 7. Be sure to thank the judges, timekeeper, teller, area AGs and anyone else responsible for the contest. Also, thank the high school speech teachers, if present.
- 8. Take photos. End.

Follow-up Checklist

- □ Send thank-you notes to speakers.
- □ Send thank-you notes to schools/coaches. Clubs may also wish to provide a token of appreciation to teachers/coaches who assisted the students.
- □ Mail or email the winner's and the first runner-up's biographies to District Chair.
- □ Make sure the winner and coach have details on the Regional level contest, inform them that parents and others are welcome to attend the Regional contest.
- □ Record the first runner-up in case the winner is unable to compete at the next level of competition.





Contest Rules

Topic: Each contestant should choose the topic of his/her speech. The purpose of the speech is to address an ethical issue using the principles of the 4-Way Test. The issue to be addressed should be something from the speaker's personal experience or general knowledge. There are no restrictions regarding the choice of topic as long as it is not blatantly offensive. If a contestant or coach is in doubt about the appropriateness of a topic, he or she should check with the Club Contest Chair. The decision of the Contest Chair will be final. <u>All speeches must be the original work of the speaker</u>.

In the speech, the topic must be specifically related to the Rotary 4-Way Test. This must be addressed during the body of the speech and not reserved for concluding statements only. **Each one of the four parts of the 4-Way Test should be addressed during the speech.** They should be specifically stated, as the intent of the speech is to use the 4-Way Test to resolve an ethical issue. The use of each element of the test could be used to prove either a positive or negative point. However, more weight will be given to an **overall positive application of the 4-Way Test** rather than a negative one.

These are to be speeches and not dramatic presentations. Although enthusiasm, good eye contact, and movement are encouraged, the student should not go to extremes. Content should be relevant and in good taste. Topics should be interesting and relevant to the speakers' interests or experiences. Students who advance to the Regional and District contests may, at their option, present the same speech given at preceding level contests or create modified or new presentations. To ensure anonymity to the judges during the contest, the speaker is **NOT** to identify themselves within the speech or identify the club they are representing. <u>2pts will be deducted from the score if they do not comply.</u>

Length: Speeches must be at least 5 minutes and no more than 7 minutes in length. Penalty points will be subtracted for time infractions, at the rate of two points for every fifteen seconds or fraction thereof that a contestant's speech runs either under the 5-minute minimum or over the 7-minute maximum.

Props: No props are to be used. Audience participation will be considered a prop. Penalty points will be subtracted for use of props or encouragement of audience participation, at the rate of two points per infraction.

Speaker Aids: At Club contests, a lectern and microphone may be provided, at the discretion of the Club. At the Regional contests a lectern may be provided and perhaps a microphone and at the District Finals contest, a lectern and microphone will be provided. **When provided, the use of the lectern is at the discretion of the speaker however the microphone should be used.**

Notes: Contestants may speak from notes at the club competition. At the Regional competition, <u>only a single 3 x 5 card</u> may be used. At the District final, <u>notes will not be allowed</u>.

Infractions of rules will result in disqualification or point deductions.

<u>Please make sure that all competitors are aware of these rules.</u>





Selection of Judges for the Club Contest

- Judges at the club level will be selected and recruited by the Club Contest Chair of the host club.
- Three judges, a timekeeper and a tabulator will be required. The timekeeper and tabulator can be the same person.
- Judges may or may not be Rotarians. In either case they must have no knowledge of or relationship to any of the speakers or their school.
- Judges should be selected on the basis of their impartiality, educational background, and familiarity with speech contests. Where available, clubs are encouraged to partner with a local Toastmasters Club to supply one or more judges. If needed contact District Chair Art Leach for assistance: <u>ArtLeach77@gmail.com</u>
- Make sure the Judges are knowledgeable about and understand the four tenets that are the 4-Way Test.

Selection of Judges for the Regional Contest

- Judges at the regional level will be selected and recruited by the Contest Chair of the host club(s).
- Three judges, a timekeeper and a teller (to tabulate the judges' scoring sheets) will be required. The timekeeper and teller can be the same person
- Judges may or may not be Rotarians. Judges should not be from a club with a regional participant. All judges must have no relationship to any of the speakers or their school.
- Judges should be selected on the basis of their impartiality, educational background, and familiarity with speech contests. Where available, clubs are encouraged to partner with a local Toastmasters Club to supply one or more judges. If needed contact District Chair Art Leach for assistance: <u>ArtLeach77@gmail.com</u>
- Make sure the Judges are knowledgeable about and understand the four tenets that are the 4-Way Test.





Judge's Instructions

General

- 1. Judges and the timekeeper/teller will seat themselves apart from each other and not communicate about their evaluations of speakers until after the teller has tallied scores.
- 2. Each speaker will be awarded points in the three categories listed below. Record points immediately after each speech. (The contest Chair will make sure judges are ready before calling the next speaker.)
- 3. Columns should be added and rankings computed after all speeches have been given and the judges have left the room.

Judging Criteria

Judging will be based on a 100-point system, broken down into three categories as follows:

- 1. Content 44 points
- 2. Organization 24 points
- 3. Delivery 32 points

NOTE: Judges may find it easier to differentiate between contestants by using partial points on the scoring sheet rather than whole numbers.

Judging Procedures

The winner of the contest will be decided by **cumulative rank order** (i.e. the sum of the ranks from all of the judges) NOT total points. Each contestant's rankings will be totaled and **the speaker with the lowest total ranking earned will be declared the winner**.

Judges will total points for each speaker on their individual scoring sheets, subtract penalty points (if any) and enter net points. Each judge then ranks the speakers 1 through "n", by the net points, with the highest score being ranked "1", the next highest, "2", and so on. If a tie exists on an individual judge's scoring sheet, the **first tiebreaker** is points scored in the "Content" category. If a tie still exists, the **second tiebreaker** is the "Delivery" category. If a tie still exists, both speakers will receive the same rank level and the next rank value will be skipped. The teller will tabulate the judges' scoring sheets.

On the Judges ranking sheet, if a ranking tie exists, the **first tiebreaker** is total net points. The contestant with the highest total of net points on the judge's scoring sheets will be declared the winner. If a tie still exists, the second and final tiebreaker will be **a vote of the judges**. The contestant receiving a majority vote of the (three) judges will be declared the winner and the judges' decision will be final. <u>There will be no ties in the final standings of the winner and</u> <u>the 1st runner-up</u>. The final results are to be recorded and presented to the Master of Ceremonies by the teller upon their return from deliberations.

- Compute penalty points, if any, at the rate of two points for every 15 seconds, or fraction thereof, that a contestant speaks under 5 minutes or over 7 minutes.
- When all the contestants have spoken, the Timekeeper retires with the judges only long enough to advise them of any penalties and present the Timekeeper's Record.
