1. Briefly describe the proposed project. What will be done, when and where will the project take place, and how many people will benefit from the project. How will the project benefit the community?

The proposed project will upgrade the electrical service to Morgan Grove Park located adjacent to the community of Shepherdstown, WV. The 20-acre Park is owned by the Shepherdstown Community Club, a 100% volunteer service organization dedicated to enriching the community. Facilities include community playground equipment; a nearly 0ne-mile walking/jogging trail; soccer, baseball and vollyball fields; a kitchen and public bathrooms, and a covered Pavilion. The Shepherdstown Community Club is a 503(c)3 non-profit organization.

The electrical service to the Pavilion is inadequate to support its on-going use for the numerous community events held there. Examples include partnering with the Shepherdstown Rotary Club's annual July 4th community picnic, Beer and Food Fest fundraiser, and various other youth and community initiatives. The project will benefit the entire Shepherdstown community through improved function and expanded use potentials.

2. How many club members will participate in the project and in what role? Is there a cooperating organization also involved and what will their role be?

The project will involve members of the Shepherdstown Rotary Club's Community Service Committee, and the Shepherdstown Community Club, the cooperating organization. The electrical upgrades will be performed by a local licensed electrical contractor coordinated by the Community Club. A member of the Community Club, also a Shepherdstown Rotarian, will proform liaison activities during completion of the project.

3. Will the project be completed if less than requested funds are granted?

If the requested funds are not fully provided, the Shepherdstown Rotary Club will have to explore other sources to fully fund the project. Hence, the Club is counting on the District to provide the dollar amount requested. If yes, will the project be modified if this occurs, and if so, how?
