



ACTIVE ORGANIZATION MEMBERSHIP

Note: Rotary only allows individuals to be members – a company/business or non-profit itself cannot be a member.

NFO! Recognizing the growing importance that organizations place on social responsibility, the club has created an organization membership option. Any organization can take part in projects that give back to the community through Rotary's well-organized structure.

The Rotary Club of Greenwood offers an organization membership program for businesses, professional practices, government entities, educational institutions, and non-profit organizations operating in the Club's area.

The organization applies for the Organization Membership option and agrees to pay for member dues and initiation fees (Invoice for each member will be sent to the organization for payment.)

An Organization Membership includes one **Primary Member** and up to three (3) **Associate Members** (other employees/associates of the organization). The Primary Member must be in a management position (senior to mid-management) in the organization. The Associate Members could be managers, communications specialists, and/or young professionals that are considered "up and coming" managers.

Each person will submit a Membership Application Form. Any new member or replacement would have to meet the club's membership criteria and be approved by the club. The Primary Member and Associate Member(s) will be identified at the time they apply to join the Club. These Members can be changed at the beginning of any quarter during the Rotary year by the Primary Member notifying the Club Secretary in writing 30 days before the start of the quarter and providing the application of the proposed replacement.

The Primary Member and Associate Members will be listed in the Club Directory and all will be considered active members. All of the members are encouraged to be actively involved in Club activities. A badge will be established for each of the members

This membership option will allow an employee of the organization to join as a full Associate member but only pay half the normal dues and application fee. It also allows replacements at the reduced application fee and the ability to transfer dues paid.

Lunch meal charge: Lunch is included in the Primary member's dues. One organizational member may attend a lunch meeting without additional charges. For attendance at lunch by more than one organizational member, a **Lunch Fee** will be required for each over one. If there are lunch charges, they will be invoiced to the organization at the end of each quarter if not paid at time of attendance. Any member may attend club lunch meetings via Zoom (if offered) for no charge.

ACTIVE-CORPORATE (club database member type)

An **Organization Primary Member** is a regular full member of the club with the same privileges as an Active member. This membership option applies to corporations, businesses, professional practices, government entities, educational institutions, and non-profit organizations.

Dues: \$480 per calendar year - The organization will be invoiced (via the Primary member) for Primary member dues of \$480 (includes lunch meals), payable one calendar year in advance (or prorate thereof) by the organization. If the organization later replaces that Primary Member, dues



paid for the member replaced will be credited to the new member on a quarterly basis and a \$50 application fee will be assessed.

Initiation Fee: Initially \$100 - If the organization later replaces that Primary Member, an **application fee** of \$50 will be charged.

Meal Fees: Lunch meeting meals are included in the dues for the Primary Member.

ACTIVE-CORPORATE-ASSOCIATE

The **Organization Associate Member** is a full Rotary member with voting rights, right to hold Director, committee chair and project lead positions, but may not hold Officer positions.

Dues: \$240 per calendar year - The organization will be invoiced (via the Associate member) for Associate member dues of \$240 (does NOT include lunch meals), payable one calendar year in advance (or prorate thereof) by the organization. If the organization later replaces that Associate Member, dues paid for the member replaced will be credited to the new member on a quarterly basis and a \$50 application fee will be assessed.

Application Fee: \$50 will be assessed for any new Associate Member.

Meal Fees: Lunch meals are NOT included with an Associate membership. Any Associate member may attend in place of the primary member without paying a meal fee. Any attendance by more than one Organizational member at a lunch meeting will incur a meal fee charge for each.

Examples: If only one member of the organization (Primary or Associate) attends a lunch meeting, there is no lunch fee charge.

If two or more members attend, there will be a lunch charge for each over one (1 charge for 2 attending, 2 charges for 3 attending).

NOTE: An Associate may participate in the Service Membership group without any additional charge.

Donations to The Rotary Foundation: For members to qualify for donation credit towards recognition awards, the donation must be made by the member or in their name. An organization may certainly make a donation, but it must be for a specific member to receive recognition credit for Paul Harris Fellow or other awards. Other questions concerning charitable donations should be addressed to the club secretary.
