It doesn't matter as long as you described the process in your DMG application It's okay to simply write them a check as long as you know the non-profit to be highly ethical

16. If your project requires a scope change you must get approval from the Grants Committee:

17. Recommended methods to document partner Club financial participation in a DMG Final Report include (include all that apply):

An email from the partner Club President

A copy of your Club's bank statement with partner Club contributions highlighted.

A sworn affidavit from the Club President and one other elected officer of the partner Club

None needed – we are all Rotarians who practice the Four-Way Test

A copy of the cancelled check from the partner Club

18. When there is a discrepancy in the benefits to non-Rotarians that actually occurred compared to what was described in the DMG application:

The Club must refund all District grant funding within 60 days or September 30, 2023, whichever occurs first.

The discrepancy must NOT be recorded in the DMG final report and any documentation (photos, etc.) suggesting things did not go as planned must be rigorously destroyed.

The DMG Final Report should describe what actually occurred and provide reasons for any discrepancy.

You must obtain District Governor approval for the discrepancy

19. If your Club spends less than the budgeted amount of funds on your DMG:

You can spend the difference on some other worthy project.

Your Club may qualify for the James P. Clyburn award for Financial Efficiency.

You must refund all TRF matching funds back to District 7980.

You may expand the project in line with the scope of the original project, with the approval of the District Grants Committee Chair.

20. If you overspend your DMG budget

It's okay as long as the Club sources the funding to make up the difference You may be required to return the District matching funds for that projet You must get written permission from the Foundation Grants Chair before you overspend

The cooperating organization is required to pay for any overspend
