Jim Oggerino Jim earned a B.S. degree in Nuclear Engineering from North Carolina State University. Subsequently he obtained a California Professional Engineer's license. Jim worked six years on a nuclear-rocket propelled, manned-mission to Mars. He developed complex computer models and identified a manufacturing defect in nozzle pressure transducers that was plaguing the testing program.

Jim left the rocket program to work domestically and internationally in the commercial electric power industry. GE work included international technical marketing of Nuclear Plant Components in Japan to Hitachi and Toshiba. Subsequently assigned as a Liaison Engineer in Switzerland, and was

Zurich from 1976 through 1979.

In 1983, Jim joined EPRI (the Electric Power Research Institute). At any given time about 1200 projects were in process in Generation, Transmission, Distribution, and Environment. Jim performed a comprehensive, two-year study for EPRI Management, comprising 100 senior electric utility executives and 1,000 staff at nine operating utilities. The goal of the study was to determine the organizational, institutional, and cultural barriers to the technology transfer of completed EPRI research. Jim and his partner found 84 impediments in 7 categories and issued a report to the industry.

After high school Roger attended Lehigh University, a school known for its engineering and business programs, earning a Bachelor of Science degree in Electrical Engineering. In the 1990's as the construction of new generating plants slowed Roger providing consulting services at operating plants and for clients like the Department of Justice and the Department of energy. In 2000 Roger began his 2nd career providing construction management services to Public Agencies and Private Entities. In 2013 Roger started Eagle Project Management, a small consulting firm that provides construction management and ADA accessibility consulting services.


