RED RIBBON RALLY A BIG SUCCESS IN WEST COVINA

Since the early 1990's, the two Rotary Clubs of West Covina, the City of West Covina and the West Covina Unified School District have sponsored a festival to educate our youth to say "NO to drugs and alcohol!" This event commemorates the ultimate sacrifice made by Drug Enforcement Agent Enrique "Kiki" Camarena on our behalf. He was kidnapped, brutally tortured and murdered by drug traffickers. This tragic event has generated the hard work of thousands of Americans...particularly our young people...who participate in Red Ribbon events during the last week in October.

Our two Rotary clubs spearheaded this large anti-drug and anti-alcohol education effort on October 29, supported by a number of important sponsors, supporters and volunteers. Thousands of families were there,



with enough kids to make your head spin. And, that's what it was all about...having the kids exposed to the message, enjoying a free pancake breakfast, providing them with stage entertainment, and the opportunity to see a number of important displays and demonstrations, particularly by our police and fire departments.

Many Rotarians were involved in setting up and preparing the food, led by President Dave Alfaro of our noon club and Caroline Chacon, President of the sunrise club. A major share of the effort was accomplished by a very large number of Interact kids from the West Covina High School. It is the largest extracurricular club on campus and can number in the hundreds. Also prominent at the rally was the hot air balloon, "Serena's Song." A wheel chair-accessible balloon, it was there through the courtesy of our Foothill Transit Co., to provide balloon rides for disadvantaged and wheelchair-bound children; and, it was enjoyed by so many of them!

This event just keeps getting better and better! Hats off to all involved...particularly the multitude of Rotary Interact Club kids from West Covina High whose help was so critically important!

DUARTE ROTARY AT WORK DAY

The Rotary Club of Duarte participated in the Rotary at Work Day on October 29th. They identified a Senior Disabled low income Duarte resident whose yard was literally out of control and volunteered to trim everything back and down. They filled a construction rolloff container, donated by Burrtec Waste, with greenwaste. Approximately 25 volunteers showed up, including members from Duarte Rotary Club, Citrus College Rotaract Club, Duarte High School Interact Club and Duarte Youthworks. When they started, the house had shrubs growing 15 to 20 feet high around the entire yard and when they left they had cut everything to 5 feet or lower.

The resident was very pleased and "while we were all very sore the next day, the physical work was very rewarding", said Kristen Petersen, President of the Duarte Rotary Club.

Covina Rotary Club is beginning a project this year that they hope will become a "signature" event for. They started with a small goal of 50 families for the first year, but have quickly increased the goal to 100. They also wanted to encourage local business', fire and police, etc. to "adopt" a familythe original goal was only 10 families, but they are moving that up as well due to overwhelming support. "I'm so excited about his project, as I've seen what a positive impact it has on the lives of residents of my home town. Lakewood has gone on to mentor surrounding cities to start their own programs; my dream for Covina Rotary is to be able to do the same" said Pam Hayes, Community Service Director for the Rotary Club of Covina.

Covina Rotary Club has a big dream...to make holiday wishes come true for residents of our community who may be in need during the upcoming season. Designed to support struggling single mom's, displaced workers, out-ofwork parents, lonely seniors and families with limited resources, this inaugural event will distribute turkeys, canned goods, dry staples and gifts in an effort to spread a little holiday cheer to friends and neighbors in need.

Covina Cares is partnering with volunteers from several local organizations, who will help collect, sort and package the contributions and assist in distribution to identified recipients on **Saturday, December 17**. We have invited the participation of local Scout troops, high schools, other community groups, YMCA, churches and interested citizens, as well as the City of Covina, who enthusiastically supports this project.

NOMINATION NEWS

Following the meeting of the Nominating Committee for Director of RI in 2007-09 on September 27, 2005 Rotary International received a formal complaint from the Rotary Club of Kerman. The RI Board of Directors reviewed the allegations at its November 4, 2005 meeting and dismissed the complaint.

In addition the Rotary Club of Kerman challenged the nomination of Paul Netzel as Director of RI for the years 2007-2009. On November 31, 2005 Ted Marsella, District Governor, notified Ed Futa, Secretary General of Rotary International, that more than one half of the Rotary Clubs of District 5230 concurred with the challenge by the Rotary Club of Kerman. There will be a ballot by mail among all of the Rotary Clubs of Zone 24 within the next few months between Paul Netzel and Ken Boyd.

The Rotary Club of Arcadia also challenged the nomination of Paul Netzel as Director of RI for the years 2007-2009. On November 11, 2005 Steve Garrett notified the District 5300 Resolutions Chairman, Ernie Jensen, that he did not want to continue the challenge process.

But wait, there is more news regarding Rotary International nominations. Following the meeting of the Nominating Committee for President of RI in 2007-08 in mid-September, Rotary International received a formal complaint alleging improper activities during the nominating process. The RI Board of Directors reviewed the allegations at its November meeting.

The Board agreed that, to protect the integrity of the nominating process, a new Nominating Committee will be convened on 5 December to select a nominee for president of Rotary International in 2007-08. All previous candidates will remain eligible.

NOVEMBER 17 2005 - UPDATE ON INDIVIDUAL GRANTS (ROTARIAN & NON-ROTARIAN TRAVEL)

At their October 2005 meeting, The Rotary Foundation Trustees agreed that Individual Grants are an important component of the Humanitarian Grants program as they support the direct service and planning missions of volunteers serving communities in need.

As a result, they agreed to lift the moratorium on Individual Grants effective 1 July 2006 for volunteer travel taking place after 1 October 2006. The Trustees will evaluate the grant program at their April 2006 meeting and will consider modifications to improve stewardship of Individual Grants and allocate resources required to process them efficiently.

At this time, TRF will not process any additional requests for Individual Grants during the 2005-06 Rotary year.
