



Dear Fellow Rotarians,

Halfway through January, winter really hasn't hit us yet.

Our thoughts aren't on snow but on fire. The views brought to us from the L.A. region bring memories that have hit close to home.

Even if you haven't lived in Sisters long, you probably have lived here in the west and have been a part of or witnessed the devastation wildfires can bring. This being said, there is work to be done, the questions are around what preparation can we do?



Bill Bartlett's article in this past week's Nugget helps us prepare in our minds. Jim Lanzarotta met with Bill B. and Jim Cornelius this past week and I followed up with Jim Cornelius as well. The discussion identified the need for a well-defined public preparedness session sometime this spring, well before our fire season gets underway.

From the early discussion this should be a full force session, providing updates for new locals and reminders for longer residents.

Hopefully to have presentations from Fire Chief Prior, the Sheriff's department for safe egress routes, specialists on preparing "go bags, or go boxes," even talks with insurance agents who can help bring understanding to closing of policies and greatly increased rates.

Discussion will hopefully begin this next week to set a date, create an agenda and gain cooperation from presenters. More details will be coming soon.

Spring is only eight 1/2 weeks away.
