Paul Spain - President (Currently in Uganda)

Born in New Jersey, Paul Spain spent his early days in the small



town of Martinsville, New Jersey. With family both in New Jersey where is mother's family lived, and New Hampshire where his father's family



lived, Paul is themiddle son between his two brothers. Moving to San Jose California in the late 60's, he attended Bellarmine College Prep and earned the rank of Eagle Scout. He attended the University of Oregon earning his BS in Finance while he worked for Sears, Roebuck at the Eugene downtown store. He married his wife Tamara in 1987 and eventually moved to Bend where he and his wife live with their 3 cats. He enjoys white water rafting, boating, skiing, golf, watching college football and, of course, traveling.

After working at Sears in San Jose and Eugene, he began a career in the insurance business as an Allstate agent, eventually becoming district manager. He returned to the agency force and acquired an independent insurance agency in Eugene. Along with his wife Tamara, they worked together to build their agency business as they had previously done with Allstate, eventually selling the agency to Washington Federal Bank where he managed the agency before leaving the insurance business and move to Bend.
