City Manager Recaps State of the City Address



The State of the City Address Recap by City Manager Bill Burrough -

Reflecting on the remarkable journey of 2024 where crime is down, and revenues are up. Winston Churchill proclaimed, "We shape our cities, and then our cities shape us." A little reminder that we must work together to build a city to be proud of. Last year, we established seven major goals, and I am proud to report on the progress and achievements of each.

Downtown Parking Solutions

Recognizing the need for an improved parking system, we initiated a comprehensive Parking Management Plan, leading to the adoption of an Integrated Smart Parking System.

Affordable Housing Strategy

As part of the Board's goal to address affordable housing, the 10-Year Affordable Housing Strategy has guided key implementation actions.

Employee Compensation & Assessment

Investing in our employees is investing in our future. In January 2024, we adjusted our employee's compensation.

Community Resource Center

The Community Resource Center at 109 Hobson is progressing as the place to find assistance for more than a cool or warm place to shelter. We have hired a manager for the center who will start March 4, 2025. We are extremely proud to have the opportunity to collaborate with local nonprofits and social service organizations, ensuring that residents in need have access to housing assistance, job placement programs, and emergency relief efforts.

Code Updates, and Comprehensive Plan Alignment

In 2024, the City of Hot Springs made significant progress on CODE FORWARD, the city's new zoning and development code, adopted on November 19. The new code modernizes zoning, streamlines business approvals, and supports sustainable development. **ASMSA Building Transition** In 2024, progress continued toward the demolition of the former St. Joseph's Hospital, currently occupied by ASMSA. Gulpha Basin Wastewater Project

Environmental sustainability remains a priority. The Gulpha Basin pump Station is now over 35% complete, with final work expected by September 2025. This initiative significantly reduces overflows and enhances environmental compliance, safeguarding our city's natural resources for future generations.

Bill also touched on the progress that has been made related to Revenue, and Public Safety (Police, Fire, Animal Services). Hot Springs remains a city of progress and opportunity, driven by infrastructure investments, economic development, and a commitment to public safety and sustainability. As we look ahead to 2025, we will continue to focus on enhancing the quality of life, supporting business growth, and fostering a thriving, connected community.
