Speaker: Mary Balkema (Introduced by Amy Remmert)

- Former City Treasurer and City Commissioner
- Focused on poverty and housing challenges in Kalamazoo
- Founded the Kalamazoo County Land Bank to stabilize blighted properties
- Director of Housing, involved with multiple nonprofits

Kalamazoo Housing Initiatives

- Budget: \$389 million, with 21% funded by the Federal Government
- 2020 Housing Millage: Passed to support housing needs
 - o One of the only counties in Michigan with a housing millage
 - Raised over \$8.6 million
 - Leveraged an additional \$115 million in funding
 - Supports both housing development and supportive services
- Housing Demand & Shortages:
 - 7,750 housing units short, while the population is increasing
 - o Affordable housing crisis: House prices have risen from 3x to 7x annual salary
 - Cost of construction is high (e.g., average lot price: \$80,000)
 - Kitchens built by prisoners in Ionia to reduce costs
- Affordability Standard: Households should pay no more than 30% of annual income on housing to be considered "non-burdened"
 - Need to earn \$19.78 per hour to afford housing in Kalamazoo

Housing Projects & Development

- Units in Progress:
 - 30 S Rose Senior Housing 64 units completed
 - o Rehabilitation of 215 units across the county
 - o 1,498 people funded through housing programs
- Future Projects:
 - 2024: County matches local business contributions for housing projects
 - o 2025: Multi-unit developments in Portage & critical repair projects
 - Awarded \$18 million for low-income neighborhoods
 - o 2026: Portage Creek Apartments \$5 million awarded
- New Housing Models:
 - o Tiny Homes (~400 sq. ft.) Cost \$100,000 each, available for lease
 - o Rivers Edge 44 single-family homes in Portage, built over 7 years
 - o 80-room hotel purchase on Old Kilgore Road to house homeless families
 - Focus on families with school-aged children (1,700 homeless students in county)

Not for surrounding counties

Supportive Services & Policy Considerations

- Millage Funds: Also pay for supportive services for those without permanent housing
- Rehabilitation vs. New Construction:
 - o Focus on rehabbing existing housing stock instead of solely building new
 - o Local governing boards must support development
- Affordable Housing & Nonprofits:
 - Funds allocated based on Area Median Income (AMI)
 - AMI for a family of 4: \$100,800
 - Funding recipients must provide a percentage of units for accommodations (e.g., for disabilities)
 - Supports YWCA and Disability Network
- Preventing Evictions: Programs in place to help prevent displacement
- No Cut to Housing Millage: Current millage has 8-year duration and is in year 4

Challenges in Housing Development

- High Interest Rates (7%) increasing costs
- Rising construction costs
- Low inventory of homes affordable for workers earning \$20-\$25 per hour
