Daylight Saving Time starts Sunday, March 9th

Daylight saving time begins on Sunday, March 9 at 2 a.m. local time.

Daylight saving time is the time between March and November when most Americans adjust their clocks ahead by one hour.

We lose an hour in March (as opposed to gaining an hour in the fall) to make for more daylight in the summer evenings.
