Rotary Legislation Explained

The Rotary Council on Legislation is a body within Rotary International that meets every three years to discuss and vote on enactments that would change the Standard Rotary Club Constitution, the RI Constitution, or the RI Bylaws. In brief, this is big stuff.

The council is meeting this year and has 84 enactments to consider. They come from districts around the world, most notably from India. Each district has one vote on the council. Our representative, **Barton Goldenberg**, is highly qualified. He invited Rotary members in our district to a Zoom meeting on March 26th and asked for our guidance on 8 of the 84 enactments, but we managed to discuss just 3 of them.

The first was: to "remove the requirement to hold an annual **district conference**." That got into the cost to the districts and RI, the numbers of participants, and more. It is truly a hard

decision. The second was to "amend the titles of the President-Elect **training** seminar and the district training assembly." This is not just semantics. The difference is whether each district will **train** its presidents-elect or will create an environment in which they can **learn**. The third was whether to "increase per capita **dues** and amend the process for determining per capita dues." A few more dollars a quarter is not huge for most of us, but what about the Rotarians in low-income countries?

It was a true pleasure to participate in the Zoom meeting with many leaders in our district. We will soon know the outcome of each of the enactments, as the council will meet in mid-April.

Leadership Montgomery

The speaker in our Zoom meeting on March 25th was Rotarian **Sara Bernett**, and her topic was **Leadership Montgomery**. Sara is the Director of Programs and Training for that organization. She got to know Rotary when our member, John Cabrera, invited her to help distribute dictionaries in elementary schools, and is now the president of her club.

Sara is a Montgomery County native. Her background includes leadership roles in the Corporate Volunteer Council and Junior Achievement. The **vision** of Leadership Montgomery, she said, is to create "...a legacy of leaders that inspire and advance Montgomery County, MD and beyond." It attempts to do this through five programs: Engage Montgomery, Leadership Essentials, Emerging Leaders, Elevate, and CORE. Also, it provides consulting and workshops.



Much of the costs are paid by participants or their companies/organizations as program fees. Benefits to the participants include an understanding of how the county works and contact with their peers and county government officials. They learn whom to reach out to for solving problems and getting things done. She reported a current downturn in applications due to uncertainties about the actions of the U.S. government.

Sara finished by telling us a bit about her Rotary, the Downtown Silver Spring Club. It focuses on youth literacy, including the "Storytown" project for giving books to children. It also has major commitments to the environment and to other Rotary priorities. The club meets at 8:00 a.m.--the first and third Friday of each month on Zoom and the second and fourth Friday at the Fenton Cafe. Visitors are welcome.
